The Chair requested staff comments on item 7.12. Gord Costie indicated staff understand the issues raised, also noting they have been heightened due to increased visitation. The master planning process for Fifty Point Conservation Area is currently underway. In the interim, changes have recently been made to the entryway to better facilitate entrance. Staff are prioritizing modernizing access for vehicles, cyclists, and pedestrians, for safety and efficiency. Staff were directed to respond to Ms. Campbell and include the Board members on the response.

#### 8. Foundation Briefing

Jennifer Stebbing reported on the following:

The Foundation received a total of **\$9,508** in donations from June 1 to 30, 2021. They break down as follows:

- \$5,500 for our Planting Fund
- \$2,518 for our Area of Greatest Need Fund
- \$1,025 for the Hamilton Watershed Stewardship Program
- The remaining \$465 was donated to the Dundas Valley Trails Fund, Westfield Heritage Village, the Land Securement Fund and the Trail Development Fund.

This brings the fiscal year-to-date (Dec 2020 to June 2021) fundraising total to **\$124,166**.

#### 12. Other Staff Reports/Memoranda

#### 12.1. Gypsy Moth Monitoring and Management – Verbal Presentation

Lesley McDonell provided a presentation with an update on the LDD (Gypsy) moth monitoring program and management practices, including a summary of Fall/Winter egg mass survey results and egg mass scraping and burlap banding control methods undertaken. At Valens and Christie, 1500 egg masses were scraped from trees and over 3000 caterpillars were removed. Lesley showed photos of trees experiencing defoliation in contrast to trees that are not affected. Defoliation monitoring is also being undertaken at the west end of the Dundas Valley, Westfield, and Borer's Falls – Rock Chapel. Lesley commented on natural controls for gypsy moth, the NVP virus and a fungus, and summarized the details of the aerial spray of btk pesticide undertaken in 2018. Egg mass surveys will continue this Fall/Winter. Defoliation forecasts from the monitoring will help to inform management options in the Spring.

Staff continue to manage all areas with this high demand and are prepared to continue through the rest of the summer season.

Good afternoon Mr. Broe-Vayda,

I am Gord Costie the Director of Conservation Area Services for the Hamilton Conservation Authority.

Your email of July 21, 2021 has been received at our Woodend main office and will be shared at the next scheduled Board of Directors meeting September 2, 2021. In advance of the Board meeting, I wanted to reply to your email so you are not waiting for over a month for response to your enquiry of trail closures near Spencer Gorge Conservation Area.

I appreciate your hiking knowledge of the Spencer Gorge Conservation Area and of your support to the HCA through your membership pass. As you note in your email, HCA has taken significant steps in requiring all entries for Dundas Peak, Tew and Webster Falls though the parking areas located in up in Greensville. The HCA Board approved a pilot reservation system from May to November 2021 and our staff are actively gathering information to bring back to the Board for 2022 recommendations.

In regards to the trial closures below the escarpment, HCA has worked closely with the city of Hamilton and the Bruce Trail Conservancy on determining the best approach in keeping people safely on managed trails while gaining access to the Spencer Gorge Conservation Area. Having a partial open trail system which brings hikers near the area was not the preferred avenue and was deemed unrealistic for trail boundaries. HCA will continue to review operations including all Bruce Side Trails at the conclusion of the reservation service and your request to reopen trails for hiking will be considered. In the interim, HCA is advising all trails below Spencer Gorge Conservation Area will remain closed until further notice.

#### **HCA Announces Official Opening of the Saltfleet Conservation Area**

HCA is pleased to announce the official opening of the Saltfleet Conservation Area to the public on September 4, 2021. The Saltfleet Conservation Area, located south of the Niagara Escarpment in the Upper Stoney Creek and Upper Battlefield Creek watersheds, offers linkages to the Dofasco 2000 Trail and the Devil's Punchbowl Conservation Area, as well as environmental features and beauty of its own.

HCA Chairman Lloyd Ferguson notes "We are thrilled to be opening the Saltfleet Conservation Area on the east escarpment to the public which provides both recreational opportunities and mitigates the impacts of climate change. With this area, we are striving to create wetlands, and provide trails and recreation with a conservation area for citizens to use and enjoy the outdoors. "

The acquisition of lands in the area, made possible through donations from the City of Hamilton and Heritage Green Community Trust, is part of a larger long-term plan, to reduce downstream flood risk and erosion to residential and commercial properties by acquiring lands, enhancing, and enlarging existing wetland areas, creating new wetland areas and restoring the natural features and functions of watercourses in the area. Once all four planned wetlands are created, the area will have the ability to hold the equivalent of 236 Olympic-size swimming pools.

The creation of the first wetland will be getting underway in late 2021.

The Saltfleet Conservation Area will include the wetland and natural areas with an associated parking lot with a direct trail connection and safe access point to the Dofasco 2000 Trail for hikers and cyclists. This is an added benefit of the new conservation area that will ease the traffic congestion at the very popular Devil's Punchbowl.

The Dofasco 2000 Trail is an 11.5 km trail which links to the Devil's Punchbowl Conservation Area with its spectacular view of the escarpment, Stoney Creek and Hamilton. The Dofasco 2000 Trail also provides access to the Vinemount Swamp. Visitors can experience the beauty of this area from the boardwalk through the swamp, giving them a unique view of the centre of a wetland.

As the additional Saltfleet Conservation Area wetlands are developed, further trails and interpretive signage will be added to enhance public access, nature appreciation and educational opportunities.

#### STAFF RECOMMENDATION

THAT HCA staff recommends to the Board of Directors:

THAT this information be reviewed for project background. Request for Tenders for this project close on Tues. Aug. 24, 2021. HCA staff will review these proposals and will provide a Summary Report with the results of the Tender opening, along with a recommendation for contract award at the Sept. 2, 2021 Board of Directors meeting.

#### **BACKGROUND**

HCA manages Confederation Beach Park, which includes Wild Waterworks on behalf of the City of Hamilton. Within WWW there are two existing water slides known as the "Blue Demon" & "Night Rider". These two tube slides were installed in 2000. Since that time these slides have experienced colour fading due to sun exposure, as well as surface blemishes and discoloration of the riding surface due to rider use and exposure to treated water. The exterior portions of these slides were most recently refurbished in 2012. With the continued closure of Wild Waterworks for the 2021 season due to the ongoing COVID pandemic, refurbishments of these slides were identified as a viable major maintenance project.

HCA Capital Projects staff retained a consultant to aid in scoping the project and to develop specifications for construction tender purposes. The scope of the project is to prepare the existing worn surfaces, complete necessary crack repairs, caulking, recoating & polishing of the interior and exterior areas of the slides.

#### STAFF COMMENT

On July 29, 2021, HCA staff issued public tender and specification documents for firms to consider in their bids. This has been advertised publicly through the online Biddingo public tender web service and sent to a variety of specific contractors who specialize in this type of work. A recommended site meeting for bidders was held on Aug. 11, 2021 to go over project specifics and address any questions the contractors had.

Tenders officially closed on Aug. 24, 2021 @ 1:00 p.m. A two-stage tender opening process followed in order to pre-qualify suitable contractors for the specialized work involved. Step 1 Qualification Packages were opened on Aug. 24, 2021 @ 1:05 p.m. Step 2 Cost Packages were opened on Aug. 31, 2021 @ 1:00 p.m. Both openings were available for public viewing online via HCA's Youtube channel.

Anticipated Project Schedule is as follows:

Aug. 24, 2021 @ 1:00 P.M. - Tender Closing

Sept. 3, 2021 - Anticipated Tender Award

Sept. 7, 2021 - Anticipated Contract Commencement

Dec. 3, 2021 - Official Substantial Completion

RE: Watershed Conditions Report

#### **SYNOPSIS**

The Hamilton Conservation Authority watershed continues to be under a Level 1 Low Water Condition, which was declared on June 16. Drought conditions will be reassessed at the beginning of September.

Monthly average streamflows this year have been, in general, significantly below long-term monthly averages. Current streamflows are significantly below the long-term average August flows, while average flows for August (to date) have been slightly below normal.

Christie Lake levels are slightly below typical levels, and HCA staff continue to actively manage reservoir levels, while also maintaining minimum flow targets for ecological health downstream in Lower Spencer Creek. The current reservoir levels in Valens Lake are within the range of typical past summer water levels.

There have been no recent or current observations or reports of significant watercourse flooding, public safety concerns, or Lake Ontario shoreline flooding.

No significant watercourse flooding, public safety concerns, or Lake Ontario shoreline flooding events are expected within the next 1 to 2 weeks.

#### **CURRENT WATERSHED CONDITIONS – August 23, 2021**

#### <u>Current Water Levels in Major Area Watercourses</u>

At this time, there are no observations, reports, or expectations of significant watercourse flooding or significant public safety concerns.

Current flows are significantly below the long-term average monthly flows for August at all five monitored locations (Upper Spencer Creek at Safari Road, Middle Spencer Creek at Highway 5, Lower Spencer Creek at Market Street, Ancaster Creek at Wilson Street, and Redhill Creek at Barton Street).

For January to June, in general the average monthly flows were significantly below the long-term average monthly flows. However, the average monthly flows in July were generally significantly above the long-term average July flows, due to received rainfall. The average monthly flows in August to date have been slightly below the long-term average August flows.

#### <u>Current Lake Ontario Water Levels</u>

At this time, there are no observations, reports, or expectations of significant shoreline flooding. The Lake Ontario mean daily water level is approximately 74.87 m IGLD85. This is about 4 cm below average for this time of year.

#### <u>Current Storages in HCA Reservoirs</u>

The current reservoir level at Christie Lake dam (about 770.65 ft) is slightly below typical levels (771.0 – 771.5 ft). HCA staff continue to actively manage reservoir levels, while also maintaining minimum flow targets for ecological health downstream in Lower Spencer Creek. The reservoir is at 62 percent of its preferred maximum storage capacity (corresponding to a water level of 773.0 ft).

The current reservoir level at Valens Lake dam (about 275.32 m) is within the range of typical past summer water levels (275.25 - 275.45 m). The reservoir is at 93 percent of its preferred maximum storage capacity (corresponding to a water level of 275.5 m).

#### **Current Soil Conditions**

The surface and root-zone soils are dry to moist, presently.

#### **RECENT STORM EVENTS**

During the period of June 22, 2021 to August 22, 2021, there were no observations, reports, or expectations of significant watercourse flooding events, public safety issues, or Lake Ontario shoreline flooding events.

#### RECENT WATERSHED LOW WATER CONDITIONS

The Hamilton Conservation Authority (HCA) watershed continues to be in a Level 1 Low Water Condition, which was declared on June 16 by the Hamilton Low Water Response Team (Hamilton LWRT).

Accompanying this declaration, the Hamilton LWRT encouraged a 10 percent reduction in water use. This applies to all users of water supplied from watercourses, waterbodies, and groundwater sources within the HCA watershed.

HCA staff continue to monitor drought conditions regularly.

#### FORECASTED WATERSHED CONDITIONS

#### Watercourse Flooding

There are currently no significant rainfall events (+20 mm in a day) forecasted for the watershed over the next 2 weeks. HCA staff continue to monitor conditions and forecasts routinely. Resultant water levels and flows from currently anticipated rain are not expected to pose significant watercourse flooding or public safety concerns.

#### Lake Ontario Shoreline Flooding

There are currently no significant Lake Ontario shoreline flooding events anticipated within the watershed over the next 9 days.

According to International Lake Ontario – St. Lawrence River Board information, Lake Ontario is expected to continue a slow, seasonal decline over the next several weeks. The rate and magnitude of water level changes will depend largely on received precipitation amounts and temperatures.

#### Watershed Low Water Conditions

Drought conditions will be re-assessed at the beginning of September.

RE: HCA Mandatory COVID 19 Vaccination Verification and

**Testing Policy** 

#### STAFF RECOMMENDATION

THAT the HCA Board of Directors endorse that the HCA draft and implement a Mandatory COVID 19 Vaccination Verification and Testing Policy requiring employees (and others as defined below) to either provide proof of vaccination, or undergo regular testing and education for those unvaccinated staff as noted in the policy outline in this report; and further

THAT the Policy applies to all HCA employees, including full time, contract, casual, volunteers, students, membership of the Board of Directors, and citizen members appointed to the Conservation Advisory Board.

#### **BACKGROUND**

In recent weeks, there have been many federal, provincial and municipal announcements regarding the implementation of mandatory COVID 19 vaccination policies. Locally, McMaster University, Mohawk College and Hamilton Police have recently introduced mandatory vaccination policies and on Thursday August 26, 2021, the City of Hamilton approved its city wide Mandatory COVID Vaccination Verification Policy.

#### STAFF COMMENT

HCA has been committed to protecting the health, safety and well being of our staff throughout the COVID 19 pandemic.

Under the Occupational Health & Safety Act, employers are obliged to take all reasonable precautions to protect the health and safety of its workers. HCA has already put in place multiple safe work procedures and protocols in this regard including daily health screening, mandatory masking and enhanced cleaning protocols for fleet, equipment and washrooms. Now, the addition of mandatory vaccination and testing policy measures demonstrates our ongoing commitment to doing everything possible to protect staff and volunteers from COVID-19 as we deliver our programs and services to the public.

HCA has looked to the City of Hamilton policy and public media releases regarding Ontario Public Service policies to model our own policy, putting the HCA in alignment with both our major municipal funder as well as our Provincial reporting Ministry, MECP.

#### Policy Outline

The mandatory policy will require the following of HCA employees, including full time, contract, casual, volunteers, students, membership of the Board of Directors, and citizen members appointed to the Conservation Advisory Board:

- Be fully vaccinated against COVID 19 OR
- Advise of a medical or human rights exception for not being vaccinated and undertake regular testing OR
- Complete a COVID 19 vaccination educational session and undertake regular testing
  - Employees (and all those others mentioned above) will be required to provide proof of their vaccination status by September 30, 2021. Those employees who have not been vaccinated, for whatever reason, or who do not disclose their vaccination status by September 30, 2021 will be required to attend mandatory education on the benefits of vaccination.
  - Proof of vaccination will consist of the documentation issued by the Ontario
    Ministry of health, other province or territory or international equivalent
    indicating individual immunization status against the COVID 19 virus. The
    procedure for collecting and storing proof of vaccination to Human Resources
    will be determined by HCA.

- Unvaccinated employees will then need to provide proof of their first dose no later than October 15, 2021. As of November 15, 2021, it will be mandatory for all staff to have received their first and second doses of a COVID 19 vaccine.
- Those employees who continue to be unvaccinated or prefer not to disclose their vaccination status will be subject to undertake regular testing for COVID 19 and provide proof of a negative result. The logistics, process and intervals for testing will be determined by HCA.
- Vaccination exemptions are subject to bona fide medical and human rights reasons and will be reviewed on a case by case basis and would be subject to HCA's accommodation process.
- No distinction shall be made between employees working remotely from home and those employees physically attending the workplace.
- HCA will support and encourage employee vaccination by providing paid time to attend COVID 19 vaccination clinics or appointments during work time.
- All employees are required to continue to practice Public Health measures to control the spread of COVID 19 regardless of their vaccination status and to adhere to all HCA safe working procedures and policies.
- Non-compliance with the policy will result in a meeting with the employee and possible discipline. Such discipline to be up to and including termination.

Should this policy outline be endorsed, a communication memo will go out to staff immediately advising of the rollout of this policy and that as additional details of the policy are finalized, we will keep all staff informed.

#### **AGENCY COMMENTS**

The City of Hamilton, the HCA's major partner and funder, notes the following in regard to their policy:

"This policy is in line with Pubic Health guidance and supports the direction that vaccines provide a high level of protection against COVID-19 and related variants. Getting both does of the COVID-19 vaccine is the best defense against the virus, including the Delta variant".

The Ontario Ministry of Health on their website states the following on vaccines:

"The will be an important tool to help stop the spread of the virus and allow individual, families and workers to safely resume normal life".

#### LEGAL/FINANCIAL IMPLICATIONS

Staff will have legal review the final policy and details once completed.

#### CONCLUSION

Consistent with our health and safety obligations and to help reduce the risk of COVID 19 transmission, a mandatory vaccination verification and testing policy is an important measure that complements other workplace health and safety procedures and policies already in place at HCA including daily health screening, mandatory masking, physical distancing, hand hygiene and enhanced cleaning.
