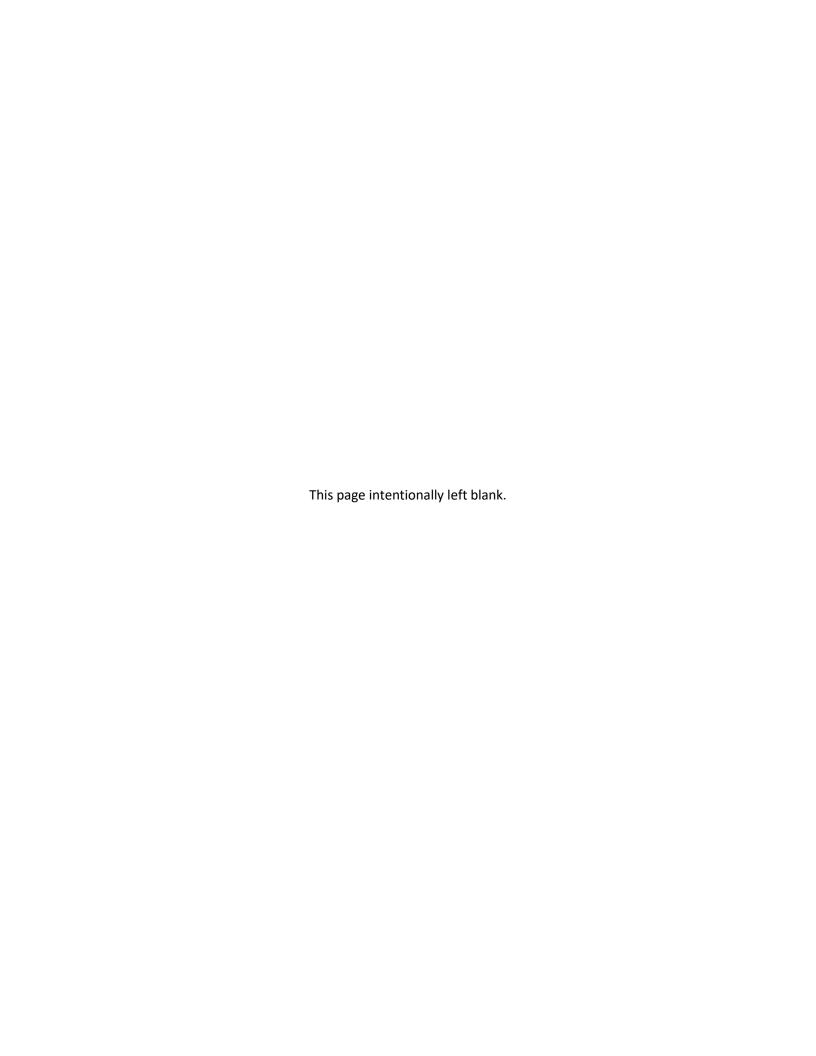

10.1. <u>Saltfleet Conservation Area Wetland Restoration Project– SC-5, Stage 3</u>
<u>Archeological Assessment Request for Proposal</u>

Scott Peck presented a summary of the report, which recommends that Archaeological Research Associates Ltd be awarded the contract to complete the required Stage 3 archeological assessment at the Sc-5 wetland, for \$727,750.

Maureen Wilson raised the question regarding the procurement policies used by conservation authorities, specifically with respect to purchasing items from Canadian suppliers. Lisa Burnside noted that each conservation authority has their own procurement policies. Given the nature of our programs and services, Lisa advised that the majority of HCA procurement would be local / Canadian. A motion regarding direction to staff was presented under New Business.

Brad Clark initiated discussion on the cost of the archaeological assessment, including additional fees for First nation monitoring, and put forward a motion to seek City support to offset the cost in efforts to help preserve the reserve account that will be needed for future expenditures. The motion recognizes past support received from the City and the benefits of the wetland project. The Board passed the motion, which Councillor Clark will bring to City Council, to request that the City of Hamilton enter into a Contribution Agreement to help support the archaeological costs for the wetland on the Punchbowl lands (SC-5) to be funded through GFL royalties or other means.

WHEREAS the Saltfleet Wetland Restoration Project is a major environmental restoration project within the City of Hamilton;

WHEREAS the wetlands will reduce the impacts of flooding and erosion below the Niagara Escarpment in Stoney Creek and further the long-term vision of the entire Saltfleet Conservation Area, which will provide new natural areas and associated habitats and trails connecting these natural areas;

WHEREAS the City of Hamilton has demonstrated its partnership and support through the provision of \$2M grant for the purposes of land acquisition for the Saltfleet Conservation Area Wetland Restoration project in 2014 funded through royalties related to the GFL Stoney Creek

Landfill Site, participation in the 2018 Environmental Assessment through technical comment and input and resolution in 2024 confirming municipal partnership to support requirements of an external fund application,

#### Therefore be it resolved:

THAT staff be directed to enter into a Contribution Agreement and any other ancillary agreement with the City of Hamilton, to facilitate the granting of \$1M for the purpose of supporting archaeological costs for the third wetland on the Punch Bowl lands (SC-5) funded through GFL royalties or other means; and further;

THAT the HCA Chair bring forward a motion to City Council to request the grant.

It is with great pride that we present the 2024 Annual Report, reflecting on a year of progress, collaboration, and commitment to conservation. This past year, we continued to build on our mission of protecting and enhancing our watershed while connecting people to nature in meaningful ways.

A significant milestone was the release of our 2025-2029 Strategic Plan, setting a strong foundation for the next five years. In the coming years, we will focus on capacity building, adapting to climate change, responding to provincial regulatory updates, and addressing emerging conservation needs. We are also enhancing visitor engagement to strengthen connections with our watershed communities and partners. We successfully secured additional federal funding from Environment and Climate Change Canada through the Canada Nature Fund, which provided financial resources to help advance the project. We also released a new video and hosted a variety of tours to expand awareness and showcase the project's vital role and benefits in protecting both people and nature.

We also celebrated the completion of the Fifty Point Wetland Restoration Project, which will help mitigate flooding and support aquatic life. Additionally, we made great progress in climate action, adding electric vehicles to our fleet and participating in key sustainability leadership initiatives.

2024 was also a year of expanding experiences for our visitors. From launching new trails and wayfinding signage to reintroducing boat rentals and improving accessibility, we are committed to ensuring that our conservation areas remain welcoming and inspiring spaces for all.

Their tireless efforts, passion, and expertise continue to drive our success and strengthen our ability to protect and enhance the natural spaces that define our region. 

#### 2024 Highlights

- HCA's 2025-2029 Strategic Plan was released, setting the path forward for the next five years to help achieve
  HCA's mission and vision. The new Strategic Plan includes four strategic priority areas: Water Resources
  Management, Organizational Excellence, Natural Heritage Conservation, and Connecting People to Nature. Several
  year-one initiatives were identified across all the strategic priority areas to launch the new plan.
- HCA's corporate Climate Change Strategy was advanced in 2024:
  - Two fully electric vehicles were added to HCA's fleet.
  - HCA became a member of Green Economy Canada's Lead Track Program and the Sustainability Leadership Program.
  - Completed ASHRAE Level II Energy Audits at the Dundas Valley Conservation Area. These reports are used to guide improvements to energy efficiency and reduce greenhouse gas emissions.
- Over \$471,868 in grants were raised for projects such as summer student positions, electric vehicle charging stations, Indigenous trail signage, environmental education, land purchases, flood plain mapping, and invasive species removal.
- Successfully completed all required provincial strategies for conservation authorities, including the Natural
  Hazard Infrastructure Asset Management Plan, Natural Hazard Infrastructure Operational Plan, Watershed-based
  Resource Management Strategy, Conservation Area Strategy, and Land Inventory, demonstrating our commitment
  to effective resource management and environmental stewardship.













#### ORGANIZATIONAL EXCELLENCE



- Supported a dynamic work culture, safe working environments, professional development, and staff effectiveness:
  - Revised and updated four safe working procedures and created four new procedures and programs for the safety of staff.
  - Provided First Aid, chainsaw operations, working at heights, confined space entry, Joint Health and Safety Committee certification, Provincial Offences Officer, and self-contained breathing apparatus training and certification. Mental health awareness and threat de-escalation, managing people, and leadership training were also provided.
  - HCA offered its third annual learning opportunity for all staff in support of the National Day of Truth and
    Reconciliation at Westfield Heritage Village Conservation Area. Hiliary Monteith and Rohini Patel, two
    postdoctoral fellows from McMaster University, introduced the topic of Traditional Ecological Knowledge
    based on the Traditional Ecological Knowledge Summit, which McMaster University held at Six Nations.
    Indigenous Elder Wilamina McGrimmond joined and shared a traditional song and drumming, reflecting
    beliefs about the environment and her own experiences. It provided an opportunity for reflection, learning,
    and discussion on Indigenous knowledge and traditions.
- Continued to increase effective communication and engagement by using the HCA Community Engagement
  website, www.conservationtalkhca.ca, an online stakeholder engagement tool for our community engagement on
  projects.
  - 3,083 people visited the HCA Community Engagement site.
  - 184 people completed surveys.
  - 384 were informed, by downloading documents, utilizing site tools like key dates, or visiting multiple project pages.
  - 1,459 visited at least one project page.
- Hosted 43 film shoots at various HCA conservation areas, providing a consistent source of self-generated revenue.
- Continued to advance HCA's due diligence in the management of its corporate records through departmental training on the Records Retention Schedule and File Classification Scheme.
- Expanded upon HCA's existing Information Technology (IT) policy, introducing a series of new IT policies to establish best practices and procedures that securely and effectively support the organization's activities.
- Collaborated and shared expertise with other conservation authorities through Conservation Ontario at numerous forums and working groups. These included the Latornell Conservation Symposium and Conservation Areas Workshop, in which HCA staff participated, presented, and assisted in the organization of the events.



### WATER MANAGEMENT

Water Management is undertaken to protect the watershed for people, property, flora and fauna, and natural resources through flood and erosion control, water quality programs, low flow augmentation and adaption strategies to adapt to changing climatic conditions.

#### WATER MANAGEMENT



#### 2024 Highlights

- Continued to promote the Saltfleet Conservation Area Wetland Restoration Project, a key focal point for HCA as part of our
  commitment to better mitigate and adapt to the impacts of climate change. The newly constructed wetlands will reduce flood
  and erosion risks, support natural heritage and wildlife, and provide local green space. We launched a new video, fact sheets
  and hosted a variety of tours for local politicians, City of Hamilton staff, and members of the public for a first-hand look at
  how it benefits our community.
- HCA Shoreline Management Plan was put forward for public consultation. In support of planning and regulation activities, this project will provide:
  - Valuable information about existing shoreline conditions.
  - Recommendations for shoreline management and protection.
  - Shoreline flood and erosion hazard information.
- Public consultation for three Floodplain Mapping projects were put forward in 2024. These projects cover the Stoney Creek
  numbered watercourses, Stoney Creek, Battlefield Creek, and Red Hill Creek systems. These projects provide necessary flood
  hazard information to support planning and regulation activities.
- · Continued to invest in monitoring programs and networks, including assessing impacts of nutrient and sediment loading:
  - Provincial water quality and groundwater quality monitoring completed for six surface water sites and seven groundwater sites.
  - Annual City of Hamilton water monitoring projects, including 364 inspections of 91 groundwater wells, 33 groundwater well water quality sampling, and erosion monitoring at 21 sites.







#### NATURAL HERITAGE CONSERVATION



#### 2024 Highlights

- Completed construction of a new wetland at Fifty Point Conservation Area in the spring of 2024. The wetland will help reduce flooding on nearby residential properties associated with Watercourse 11 and promote the establishment of a self-sustaining fishery in the pond, providing visitors with additional fishing opportunities. The wetland features provide additional natural areas and habitat diversity within the conservation area.
- Improved ecosystem health by removing thousands of invasive plants, restoring over 33,000 square metres of natural habitat, and protecting biodiversity within the watershed:
  - Managed 20 different invasive species including Phragmites, common buckthorn, Dog-strangling Vine, Japanese knotweed, Multiflora rose, Tree of heaven, common teasel, cutleaf teasel, autumn olive, invasive honeysuckles, garlic mustard, and Chinese privet.
  - Treated over 38 specific sites in the following areas: Beverly Swamp, Christie Lake, Copetown Bog, Devil's
    Punchbowl, Dundas Valley, Eramosa Karst, Felker's Falls, Fifty Point, Fletcher Creek, Spencer Gorge, Saltfleet,
    Valens Lake, Westfield Heritage Village, and more.
  - 97 garbage bags of invasive plants were removed, and a total of 3,356 stems of invasive trees and shrubs were pulled.
  - 27,471 square metres of invasive species were treated, and another 5,816 square metres of invasives were brush cut.

#### NATURAL HERITAGE CONSERVATION



- Enhanced natural heritage features with restoration projects across our watershed:
  - Five truckloads of Christmas trees were collected from the Dundas waste transfer station and utilized for aquatic restoration projects in Ancaster Creek.
  - 164 trees and shrubs and 10lbs of seeds were planted in the Lower Spencer Creek.
  - An additional 712 trees and shrubs were planted in additional stewardship projects.
- Partnered with the Royal Botanical Gardens to replace over 1.3-kilometres of wildlife barrier fencing along Cootes
  Drive in Dundas. Providing a stable barrier helps reduce vehicle strikes on Cootes Drive, where wildlife such as
  snakes, frogs, and turtles migrate.
- Stewardship staff completed 32 projects involving 26 landowners, with a total value of \$29,500. 12 of these projects were completed through the Water Quality Habitat Improvement Program (WQHIP). These projects helped improve wildlife habitat and water quality in our watershed through project development, invasive species removal, and general inquires.
- Mitigated hazards by removing 628 hazard trees from HCA areas. 59% of these trees were affected by the invasive Emerald Ash Borer. An additional 138 trees were pruned.

#### **CONSERVATION AREA EXPERIENCE**



#### 2024 Highlights

- Launched the new trail map and wayfinding signage system at Eramosa Karst Conservation Area, setting a new standard for visitor information and safety. The comprehensive system features trailhead welcome signs that include maps, area, and trail information, and rules and safety tips; secondary entrance signage; and directional signposts at trail intersections. Trail maps now feature trail surfaces, estimated hike times, and trail ratings, from accessible to difficult. QR codes linking to trail maps and area information are also posted throughout the trail system. This implementation at Eramosa Karst marks the first in a series of signage upgrades planned for other HCA conservation areas in the coming years.
- Achieved a Diamond Elite rating under the Clean Marine Program through Boating Ontario at the Fifty Point
  Conservation Area marina. This is the highest award given for protecting waterways and was achieved by
  implementing environmental initiatives such as a new shrink wrap recycling program, educating and increasing
  boaters' awareness, proper disposal of materials, energy consumption, and maintaining high operational standards.
- Resumed boat rentals at Christie Lake and Valens Lake Conservation Areas in the summer of 2024, following
  a pandemic-induced hiatus. Visitors welcomed canoe rentals at both locations, while Valens Lake expanded its
  offerings to include kayaks and rowboats.
- Opened the new West Wetlands Trail at Saltfleet Conservation Area, providing further access and opportunities to enjoy the conservation area.
- Celebrated Westfield Heritage Village Conservation Area's 60th anniversary in June. To mark the occasion, a new logo was unveiled highlighting the area's cultural and natural heritage. A new interactive and accessible garden was also installed.





#### **CONSERVATION AREA EXPERIENCE**



- Expanded online advanced day passes to two additional HCA conservation areas, Saltfleet and Eramosa Karst. Day
  passes offer quick and easy entry to HCA areas and provided swift entry for the 1,919 people who purchased in
  2024, up 26% from 2023.
- Restored Valens Lake Conservation Area's beloved fishing bridge after it caught fire in October. Though the
  flames were quickly extinguished, the bridge suffered severe damage. An outpouring of support from the local
  community and work from our dedicated staff, ensured the bridge was repaired in record time and was reopened
  for Thanksgiving weekend.
- Invested in projects to enhance and expand recreation experiences including:
  - Fifty Point Conservation Area entranceway was rebuilt to improve pedestrian safety and streamline the flow of traffic into the area.
  - Main entrance signs were replaced at Dundas Valley and Westfield Heritage Village Conservation Areas.
  - Dundas Valley, Fifty Point, and Hamilton Mountain Conservation Areas, and Confederation Beach Park received a total of 14,500 square metres of road and parking area improvements throughout their areas.
  - Over 120-metres of boardwalk was replaced on the Lafarge 2000 Trail.
  - Confederation Beach Park lookout platform at Lakeland Centre was replaced.
  - Accessible beach trail was rebuilt at Christie Lake Conservation Area, and five pads for accessible picnic tables were also installed.
- Completed several Master and Management Plans to provide HCA with a long-term vision, guiding the effective management, restoration, and improvement for the following conservation areas:
  - Saltfleet Masterplan, Devil's Punchbowl Masterplan, Winona and Vinemount Management Plans, and Dofasco 2000 Trail Management Plans were finalized and approved by HCA's Board of Directors.



#### **EDUCATION & ENVIRONMENTAL AWARENESS**



#### 2024 Highlights

- March Break camps returned to the Dundas Valley Conservation Area for the first time since 2019, offering flexible single-day and full-week registration options. These engaging camps successfully blended education and fun, covering topics like local wildlife, ecosystem dynamics, and sustainable practices to help engage young minds in the importance of conservation and environmental stewardship.
- Engaged youth in environmental education through interactive activities at the Hamilton Children's Water Festival. HCA staff ran two different activities, highlighting invasive species and salmon life cycles to foster awareness and appreciation for aquatic ecosystems.
- Hosted the Watershed Steward's Appreciation Day at Fifty Point Conservation Area in October. Two landowners
  within HCA's watershed were recognized and presented with a Watershed Stewardship Award. The day also
  celebrated the 30th anniversary of the Hamilton Watershed Stewardship Program and featured a tour of the new
  Fifty Point wetland.
- Enhanced stewardship programs for both urban and rural areas through the Hamilton Watershed Stewardship Program including:
  - Three wells decommissioned.
  - \$19,785 in funding provided.





#### **EDUCATION & ENVIRONMENTAL AWARENESS**



- Co-hosted the annual Greater Toronto and Hamilton Area Invasive Species Working Group field tour with Credit Valley Conservation and Royal Botanical Gardens. The tour provided a day of site visits and fruitful discussions around monitoring and management techniques. The group contains over 30 members from conservation authorities, municipalities, and other environmental organizations.
- Increased awareness and education of local invasive species through:
  - Eight blogs published highlighting invasive species, how they are spread, common ones in the area, HCA staff, reporting, and more.
  - Invasive species signage about Jumping worms was installed in the Dundas Valley Conservation Area.
- Began offering a free turtle nest protector rental program, where turtle nest protectors were available to
  landowners in the HCA watershed who encounter nesting turtles on their property. This free rental program
  allowed landowners to use a turtle protector for the duration of the nesting season, and the protectors returned
  after the hatchlings emerged.







## MESSAGE FROM HAMILTON CONSERVATION FOUNDATION

The Hamilton Conservation Foundation is proud to partner with HCA to safeguard and enhance our region's natural and cultural heritage. Through our fundraising efforts and responsible stewardship, we help support HCA's vital work, which contributes to the long-term preservation of the area's ecological health and community well-being.

#### 2024 at a Glance

In the 2023-2024 fiscal year, the Foundation raised nearly \$900,000. Thanks to the generosity of our donors, we contributed approximately \$878,000 toward several key HCA priority projects.



RE: Updates to HCA Administrative By-Law and Hearing

#### STAFF RECOMMENDATION:

THAT the Budget & Administration Committee recommends to the Board of Directors:

THAT the Administrative By-Law and Hearing Guidelines be amended with the revisions noted in the attached draft, subject to and including any further revisions as noted during the March 25, 2025 meeting.

#### **BACKGROUND & PURPOSE**

The HCA Administrative By-Law is based on a model by-law provided by Conservation Ontario which has been widely adopted by most other Conservation Authorities. The Budget & Administration Committee undertakes an annual review of HCA's Administrative Bylaws (the "Governance Policies") as part of their terms of reference.

The purpose of this report is to seek Board adoption of amendments that have been incorporated to address the following:

- Correction to reflect the previous statutory objects in the Conservation
   Authorities Act were changed to the Statutory purpose during a previous
   iteration of the Act;
- Align language in Ontario Regulation 402/22 Budget and Apportionment;

- Delegated authority to senior staff for permits under Section 28 of the Conservation Authorities Act;
- Ministerial approval for exceptions to legislated requirements for the rotation of the Chair and Vice-Chair among participating municipalities, and maximum term limits for the Chair and Vice-Chair;
- Optional participation in remuneration for Directors;
- Updates to the Conservation Authorities Act Hearing Guidelines to address five scenarios under which hearings can now be held following changes to the Conservation Authorities Act that came into effect on April 1, 2024.

#### STAFF COMMENT

#### Conservation Ontario Amendments

Conservation Ontario conducted its annual review of the model by-law and brought forward amendments to Conservation Ontario Council at the December 9, 2024 meeting. The amendments were minor in nature and primarily updated language to align with *Ontario Regulation 402/22 Budget and Apportionment*. These amendments were approved by Conservation Ontario Council and as such have been included for consideration in this proposed update to HCA's draft administrative by-law.

#### Housekeeping Amendments

On April 4, 2024, in accordance with the *Conservation Authorities Act* and *Ontario Regulation 41/24*, the Board of Directors delegated approval of permit applications, extensions, and cancellations, as well as administrative reviews of permit applications and permit fee reconsiderations to select senior staff. Footnotes in the by-law have been updated to reflect the new terms of delegated authority to staff.

Further to a decision by the Minister of Natural Resources on January 28, 2025 approving HCA's application for exceptions to provisions in the *Conservation Authorities Act* requiring annual rotation of the Chair and Vice-Chair positions among participating municipalities and term limits for the Chair and Vice-Chair positions, footnotes in the bylaw have been updated to reflect the Minister's decision and the validity of the exceptions for the 2025 and 2026 terms.

Following approval at the December 5, 2024 Board of Directors meeting for the provision of optional remuneration for Board of Directors and Advisory Board and Committee members, a clause has been added to the by-law noting optional participation.

Additional minor amendments have been incorporated into the by-law, such as a correction to retroactively reflect the legislative change of the previous statutory objects in the *Conservation Authorities Act* to a legislative purpose statement and a clause

codifying the discretion of the Chair to expel delegates or members of the public from a meeting where respect of reasonable rules of decorum is not observed.

The above recommended amendments are attached as track changes in the draft Administrative By-law.

#### **Hearing Guidelines**

The Conservation Authorities Act Hearing Guidelines ('Hearing Guidelines') were first released jointly by the Ministry of Natural Resources and Forestry and Conservation Ontario in 2005 and have been subject to periodic review and amendment since that time. The purpose of the Hearing Guidelines is to provide Conservation Authorities with protocols and procedures for the holding of hearings pursuant to the Conservation Authorities Act, and for ensuring that hearings meet the requirements of the Statutory Powers Procedures Act. The guidelines are also intended to promote consistency across Conservation Authorities with respect to the holding of hearings.

The Hearing Guidelines are made available to Conservation Authorities to adopt in whole and/or to adapt to suit individual Authority needs, policies and processes. HCA has generally adopted the Conservation Ontario model Hearing Guidelines in their entirety, with some specific changes and amendments to suit HCA practices for the holding of hearings, including direction to:

- Provide that hearings will be held according to a bi-monthly hearing date schedule; and
- Provide for the holding of hybrid (in-person and electronic) hearings.

On December 9th, 2024, Conservation Ontario Council approved amendments to the *Conservation Authorities Act Model Hearing Guidelines*. These amendments were made to address and implement changes to the *Conservation Authorities Act* that came into effect on April 1, 2024. In particular, the guidelines required updates to reflect additional provisions in the *Conservation Authorities Act* and *Ontario Regulation 41/24* that provide opportunities for hearings. Hearings may be required under a number of different scenarios, including related to the refusal of a permit application, attachment of conditions to a permit, cancellation of a permit, refusal of a permit extension and the issuance of a stop work order. The scenarios under which a hearing may be required, and the associated decision powers of a Hearing Board, are summarized in Tables 1 and 2 of the updated Hearing Guidelines.

Given the expanded scenarios under which a hearing can be held, staff propose the updated Hearing Guidelines prepared by Conservation Ontario be adopted in full, replacing the existing guidelines, and incorporated into HCA's Administrative By-Law. The basic proceedings and HCA-specific amendments that are currently included in the hearing guidelines in HCA's Administrative By-Law would continue and be carried

forward in the new guidelines. The updated guidelines proposed for adoption are appended to this report.

#### CONCLUSIONS

Amendments to HCA's Administrative Bylaw and Hearing Guidelines, as outlined in this report, are required to reflect current practice and to ensure the document remains relevant and current. The adoption of updated Hearing Guidelines is required in order to adapt to and implement changes to the *Conservation Authorities Act* that came into effect in 2024.

#### Introduction

#### 1. The Hamilton Region Conservation Authority

The Hamilton Region Conservation Authority (the "HCA" or the "Authority") is a non-share corporation, established under Section 3 of the Conservation Authorities Act (the Act), the objects to provide, in the area over which it has jurisdiction, programs and services designed for the purpose of furthering the conservation, restoration, development and management of natural resources in watersheds, other than gas, oil, coal and minerals.

Under the Act, municipalities within a common watershed are enabled to petition the province to establish a conservation authority.

Members of the Authority are appointed as representatives by the Participating Municipalities and are effectively directors also of the Authority. The HCA is comprised of its members (who form the Board of Directors), appointed as representatives by the Participating Municipalities, namely the City of Hamilton and the Township of Puslinch. An additional member may be appointed to the authority by the Minister as a representative of the agricultural sector.

#### 2. Statutory objects purpose

The statutory <u>objects\_purpose</u> of the HCA, as set out in <u>subsection 20(1)0.1</u> of the Act, <u>areis</u>: <u>To to provide for the organization and delivery of programs and services that further conservation, restoration, development and management of natural resources in watersheds in Ontario.</u>

establish and undertake programs to further the conservation, restoration, development and management of the renewable natural resources within the HCA watershed.

The HCA pursues these programs for the benefit of the people of the Hamilton region and the people of the Province of Ontario.

#### 3. The HCA's mission and vision

The mission of the HCA is to lead in the conservation of our watershed and connect people to nature.

The HCA's vision is a healthy watershed for everyone.

#### 4. The HCA's powers

The HCA must always act within the scope of its powers. As a non-share capital corporation, the HCA has the capacity and, subject to the Act and other applicable legislation, the rights, powers and privileges of a natural person.

The powers of a conservation authority to accomplish its objects are set out in the Act, including those identified under subsection 21(1) of the Act, which states:

#### Powers of authorities

- 21 (1) For the purposes of accomplishing its objects, an authority has power,
  - (a) to research, study and investigate the watershed and to support the development and implementation of programs and services intended to further the purposes of this Act
  - (b) for any purpose necessary to any project under consideration or undertaken by the authority, to enter into and upon any land and survey and take levels of it and make such borings or sink such trial pits as the authority considers necessary;
  - (c) to acquire by purchase, lease or otherwise any land that it may require, and, subject to subsections (2) and (4), to sell, lease or otherwise dispose of land so acquired;

- (d) despite subsection (2), to lease for a term of five years or less land acquired by the authority;
- (e) to purchase or acquire any personal property that it may require and sell or otherwise deal therewith;
- (f) to enter into agreements for the purchase of materials, employment of labour and other purposes as may be necessary for the due carrying out of any project or to further the authority's objects;
- (g) to enter into agreements with owners of private lands to facilitate the due carrying out of any project;
- (h) to determine the proportion of the total benefit afforded to all the Participating Municipalities that is afforded to each of them;
- (i) to erect works and structures and create reservoirs by the construction of dams or otherwise;
- (j) to control the flow of surface waters in order to prevent floods or pollution or to reduce the adverse effects thereof;
- (k) to alter the course of any river, canal, brook, stream or watercourse, and divert or alter, as well temporarily as permanently, the course of any river, stream, road, street or way, or raise or sink its level in order to carry it over or under, on the level of or by the side of any work built or to be built by the authority, and to divert or alter the position of any water-pipe, gas-pipe, sewer, drain or any telegraph, telephone or electric wire or pole;
- (I) to use lands that are owned or controlled by the authority for purposes, not inconsistent with its objects, as it considers proper;
- (m) to use lands owned or controlled by the authority for park or other recreational purposes, and to erect, or permit to be erected, buildings, booths and facilities for such purposes and to make charges for admission thereto and the use thereof;
- (n) to collaborate and enter into agreements with ministries and agencies of government, municipal councils and local boards and other organizations and individuals;
- (o) to plant and produce trees on Crown lands with the consent of the Minister, and on other lands with the consent of the owner, for any purpose;
- (p) Repealed;

(p) Repealed

(q) generally to do all such acts as are necessary for the due carrying out of any project or as

### may be desirable to further the objects of the authority. 5. Area of jurisdiction

The HCA has jurisdiction in all matters provided for in the Act, over the area under the HCA's jurisdiction.

The HCA's area of jurisdiction consists of the watersheds of Spencer Creek and all other streams entering Lake Ontario, including any bays or inlets thereof, from the point where the northeast boundary of the Spencer Creek watershed meets the shore of Lake Ontario to the point where the northwest boundary of the Niagara Peninsula Conservation Authority meets the shore of Lake Ontario.<sup>1</sup>

#### A. Definitions

- "LevyApportionment" means the amount of <u>net</u> costs apportioned to Participating Municipalities in accordance with the Act and Regulations under the Act.
- "Authority" means the Hamilton Region Conservation Authority.2
- "Act" means the Conservation Authorities Act, R.S.O. 1990, chapter C.27
- "Board of Directors" means all of the members of the Authority, collectively.3
- **"Chair"** means the Chairperson as referenced in the Act as elected by the Directors of the Authority.
- "Chief Administrative Officer" means the Chief Administrative Officer of the Authority, and which may, by resolution of the Authority, include the responsibilities of the Secretary-Treasurer if so designated by resolution of the Authority.
- "Directors" shall mean the members appointed to the Authority by the Participating Municipalities in the Authority's area of jurisdiction and effectively act as directors as specified in the Ontario Not-For-Profit Corporations Act (ONCA).
- "HCA" means the Hamilton Region Conservation Authority.
- "Majority" means half of the votes plus one.
- "Minister" means the Minister responsible for administration of the Act.
- "Officer" means an officer of the Authority as empowered to sign contracts, agreements and other documents on behalf of the Authority in accordance with section 19.1 of the Act, which shall include the Chair, Vice-Chair, Chief Administrative Officer, Deputy Chief Administrative Officer and the Secretary-Treasurer.
- "Participating Municipality" means a municipality that is designated by or under the Act as a participating municipality in a conservation authority. The Participating Municipalities of the HCA are the City of Hamilton and the Township of Puslinch.
- "Pecuniary Interest" includes the financial or material interest of a Director and the financial or material interest of a Director or the Director's immediate family.
- "Secretary-Treasurer" means Secretary-Treasurer of the Authority with the roles specified in the Act.
- "Staff" means employees of the Authority as provided for under Section 18(1) of the Act.
- "Vice-Chair" means the Vice-Chairperson as elected by the Directors of the Authority.

#### **B.** Governance

#### 1. Directors

#### a) Appointments

Participating Municipalities within the jurisdiction of the Hamilton Conservation Authority may appoint Directors in accordance with Section 14 of the Act. An additional member may be appointed to the authority by the Minister as a representative of the agricultural sector.

Directors must reside in a Participating Municipality within the Authority's area of jurisdiction and may include citizens as well as elected members of municipal councils.

Collectively, the appointed Directors for the purposes of this by-law are referred to as the Board of Directors.<sup>4</sup>

At least 70% of a municipality's appointees must be selected from among the members of the municipal council, unless the municipality obtain permission from the Minister to select less than 70% of its appointees from among the members of the municipal council.<sup>5</sup>

#### b) Term of Director Appointments

In accordance with Section 14 of the Act, a Director shall be appointed for a term of up to four years at the discretion of the appointing municipal council; such term beginning at the first meeting of the Authority following his or her appointment and ending immediately before the first meeting of the Authority following the appointment of his or her replacement. The Secretary-Treasurer shall notify the appropriate municipality in advance of the expiration date of any Director's term, unless notified by the municipality of the Director's reappointment or the appointment of his or her replacement. A Director is eligible for reappointment. A Director can be replaced by a Participating Municipality at the municipality's discretion prior to the end of their term. The Minister will define the term for the Member they appoint as a representative of the agricultural sector and they may be replaced at the Minister's discretion.

#### c) Powers of the Board of Directors

Subject to the Act and other applicable legislation, the Board of Directors is empowered without restriction to exercise all of the powers prescribed to the Authority under the Act. In addition to the powers of an Authority under s.21 of the Act for the purposes of accomplishing its objects, as referenced in the introduction of this By-law, the powers of the Board of Directors include but are not limited to:

- a) Approving by resolution, the creation of Committees and/or Advisory Boards, the members thereof and the terms of reference for these Committees and/or Advisory Boards;
- b) Appointing a Chief Administrative Officer and/or Secretary-Treasurer;
- c) Terminating the services of the Chief Administrative Officer and/or Secretary-Treasurer.
- d) Approving establishing and implementing regulations, policies and programs;
- e) Awarding contracts or agreements where the approval of the Authority is required under the Authority's purchasing policy.

- f) Appointing an Executive Committee and delegate to the Committee any of its powers except:
  - The termination of the services of the Chief Administrative Officer and/or Secretary-Treasurer,
  - ii. The power to raise money, and
  - iii. The power to enter into contracts or agreements other than those contracts or agreements as are necessarily incidental to the works approved by the Authority.
- g) Approving by resolution, any new capital project of the Authority;
- h) Approving by resolution, the method of financing any new capital projects;
- i) Approving details on budget allocations on any new or existing capital projects;
- j) Approving <u>ef</u> the total budget for the ensuing year, and approving the <u>levies apportionment</u> to be paid by the Participating Municipalities;
- k) Receiving and approving the Financial Statements and Report of the Auditor for the preceding year;
- I) Authorizing the borrowing of funds on the promissory note of the Authority in accordance with subsection 3(5) of the Act;
- m) Approving by resolution, any acquisition or disposition of land, subject to the requirements under the Act;
- n) Approving, extending or cancelling permits, or refusing permission, as may be required under any regulations made under Section 28 of the Act, including the delegation of this responsibility to Chief Administrative Officer or other Authority staff consistent with such regulations; [IJT1]
- e)—Holding hearings required for the purpose of reviewing permit applications, and advising every applicant of their right to appeal the decision to the Ontario Land Tribunal.<sup>7</sup>

If a Member has been appointed representing the agricultural sector, they do not have a vote on items i, j, and k as per s.14 of the Act and s.2 of Ontario Regulation 402/22 Budget and Apportionment.

#### d) Responsibilities and Functions of the Board of Directors

The Board of Directors is responsible for the overall management of the Authority, with a focus on five main functions: (a) strategic planning, (b) financial oversight, (c) the development of corporate policy, (d) executive management oversight; and (e) governance and legal compliance.

Monthly summary reports of the permits issued are submitted to the Board for information purposes as part of each monthly meeting package. HCA permit applications for the 2-year time frame that do not comply with HCA policy or permit applications for a period of 5-years are presented to the Board through a Staff report for consideration.

The earing procedures for hearings under s. 28(3) of the Act are set out in Appendix 5. Any hearing or appeal dealt with in this By-law may, at the discretion of the Chair, be conducted electronically with provisions for applicants and their agents to participate if the Authority decides to hold any such hearing or appeal.

- a) <u>Strategic Planning</u>: The Board will adopt a strategic planning process, approve short-term and long-term strategic plans, and monitor the performance of the HCA against those plans.
- b) <u>Financial Oversight</u>: The Board will monitor the HCA's finances, including its future financial viability. The Board will ensure that the HCA is operated in a sound and prudent fiscal manner, and shall undertake short- and long-term financial planning consistent with the HCA's mission, objectives and strategic plan. The Board will do so with the assistance of Staff and the Budget and Administration Committee. Specifically, the Board will:
  - i. review and approval annual budgets, including municipal levies;
  - ii. review and approve budget adjustments during the current budget year;
  - iii. review and approve the annual audit and the auditor's report; and
  - iv. regularly scrutinize and investigate all aspects of HCA's finances and, when necessary, determine appropriate actions.
- c) <u>Corporate Policymaking</u>: The Board will ensure the existence of corporate policies to govern the HCA in key areas, including, and in addition to those separately identified in this Section:
  - i. the mission, vision and objectives of the HCA;
  - ii. good corporate governance;
  - iii. ethical conduct by HCA employees and Directors;
  - iv. equity, diversity, non-discrimination, harassment and abuse;
  - v. privacy; and
  - vi. health and safety.

In ensuring the existence of these policies, the Board will strive, to the extent reasonably possible, to promote a culture of honesty, integrity, equitable treatment, legal compliance and good governance, in which the purposes of the HCA are realized, employees are protected from occupational injury and disease, and visitors are provided safe and healthy facilities in which to enjoy the natural environment.

The work of the Board in connection with policy development is generally confined to establishing rather than implementing policies. Further development of these policies and implementation is delegated to the CAO, subject to Board oversight.

- d) Executive Management Oversight: The Board will appoint, evaluate and, if necessary, terminate the CAO. The Board will define the duties and limits of authority of senior management. The Board will satisfy itself as to the integrity of the CAO and other senior managers. The Board is responsible for succession planning for the CAO.
  - The Board's primary connection to the operational organization will be through the CAO or his/her delegate, or through such other person(s) as the Board may designate.
- e) Governance and Legal Compliance: The Board will assess the effectiveness of the Board and its Committees on an ongoing basis. The Board is responsible for assuring that the HCA governs itself in accordance with principles of effective corporate governance, and that the HCA complies with all applicable laws and regulations.

#### e) Director Accountability

Participating Municipalities appoint Directors to the Authority as their representatives. Directors have the responsibilities of Directors of the corporation that is the Authority. While the Chief Administrative Officer and other staff of the authority are responsible for the day-to-day operations, the Board of Directors is responsible for matters of governance, ensuring compliance with applicable legislation, and ensuring appropriate policies are in place and for financial soundness of the Authority.

Every member and officer in exercising his/her/their powers and discharging his/her/their duties to the Authority shall act honestly and in good faith with a view to the best interests of the Authority and exercise the care, diligence and skill that a reasonably prudent person would exercise in comparable circumstances.

All Directors have the responsibility to be guided by and adhere to the Code of Conduct (Appendix 1) and Conflict of Interest Policy (Appendix 2), as adopted by the Authority. Additionally, the agricultural representative appointed by the Minister will be required to follow the provincial ethical framework set out for government public appointees in the Management Board of Cabinet's Agencies and Appointments Directive.

Directors are responsible for:

- a) Attending all meetings of the Authority;
- b) Understanding the purpose, function and responsibilities of the Authority;
- c) Being familiar with the Authority's statutory and other legal obligations;
- d) With the administration, setting strategic direction for the Authority.

#### f) Applicable Legislation

In addition to the Act, the Directors are subject to other legislation including, but not limited to:

- Municipal Conflict of Interest Act:
- Municipal Freedom of Information and Protection of Privacy Act; and
- Not-for-Profit Corporations Act, 2010

If any part of this by-law conflicts with any provision of the Municipal Conflict of Interest Act or the Municipal Freedom of Information and Protection of Privacy Act or a provision of a regulation made under one of those acts, the provision of that act or regulation prevails. The same applies to conflicts between these by-laws and the Not-for-Profit Corporations Act except where dictated by the *Conservation Authorities Act* in which case the Act prevails.

#### g) Relationship Between Directors and Staff

The Chief Administrative Officer shall manage the operations of the organization, including all employees of the Authority. The Chief Administrative Officer is accountable to the Authority, working cooperatively to achieve the goals established by the Directors.

The Board of Directors will ensure that a process exists for regular performance evaluations of the Chief Administrative Officer.

The CAO has the full charge and direction of all employees of the Authority, and is responsible for directing and coordinating the execution of programs, policies and decisions which the Board of Directors approves or adopts. The CAO provides information and serves as liaison to the member municipalities as required by the Chair and the Board of Directors, and conducts the official correspondence of the Authority.

The CAO is accountable to the Board of Directors. The CAO reports to the Chair and brings issues to the Board on a timely basis.

All Board authority delegated to Staff is delegated through, or with notice to, the CAO. The Board will never give instructions to persons who report directly or indirectly to the CAO, without notice to the CAO. Staff are accountable to the CAO. Board decisions and policies, including this Administrative By-Law, as well as long- and short-term planning documents, communicate the intent of the Board, direct the CAO to achieve certain results, and constrain the CAO to act within acceptable boundaries of prudence and ethics. The CAO is authorized to establish all further policies, make all decisions, take all actions and develop all activities as long as they are consistent with or reasonable interpretations of the Board's decisions and policies. The Board will respect and support the choices of the CAO while working the CAO's area of discretion. No individual Director, Officer or committee has authority over the CAO unless authorized by the Board.

#### h) Governing Style

Friendly Atmosphere: The Board will continue to foster a friendly and constructive atmosphere, with good rapport among members and between Directors and Staff.

Focus: The Board will govern lawfully, with an emphasis on:

- a) outward vision rather than an internal preoccupation;
- b) encouragement of diversity of viewpoints;
- c) strategic leadership more than administrative detail;
- d) clear distinction of Board and CAO;
- e) collective rather than individual decisions;
- f) future rather than past or present, and;
- g) proactivity rather than reactivity.

Group Responsibility: The Board will cultivate a sense of group responsibility. The Board will be responsible for excellence in governing. The Board will use the expertise of individual members to enhance the ability of the Board as a body rather than to substitute individual judgments for the HCA's values. The Board will allow no Officer, individual or committee of the Board to hinder or be an excuse for not fulfilling group obligations.

Long-range Planning: The Board's major policy focus will be on the intended long-term effects outside the organization, not on the administrative or programming means of attaining those effects.

Self-Discipline: The Board will enforce upon itself and its members whatever discipline is needed to govern with excellence. Discipline will apply to matters such as attendance, preparation, policy-making principles, respect of roles, and ensuring continuance of governance capability. Although the Board can change its governance policies at any time, it will observe those currently in force scrupulously.

#### 2. Officers

The Officers of the Authority, and their respective responsibilities, shall be:

Chair

a) Is a Director of the Authority;

- b) Presides at all meetings of the Board of Directors (and Executive Committee if applicable);
- c) Calls special meetings if necessary;
- d) Acts as a public spokesperson on behalf of the Board of Directors;
- e) Serves as signing officer for the Authority;
- f) Ensures relevant information and policies are brought to the Authority's attention;
- g) Keeps the Board of Directors apprised of significant issues in a timely fashion;
- h) Performs other duties when directed to do so by resolution of the Authority.

#### Vice-Chair

- a) Is a Director(s) of the Authority;
  - b) Attends all meetings of the Authority (and Executive Committee if applicable);
  - c) Carries out assignments as requested by the Chair;
  - d) Understands the responsibilities of the Chair and acts as Chair immediately upon the death, incapacity to act, absence or resignation of the Chair until such time as a new Chair is appointed or until the Chair resumes his/her duties;
  - e) Serves as a signing officer for the Authority.

#### Chief Administrative Officer (CAO)

Responsibilities of the CAO as assigned by the Authority include, but are not limited to the following:

- a) Is an employee of the Authority;
- b) Attends all meetings of the Board of Directors (and Executive Committee if applicable) or designates an acting CAO if not available;
- c) Works in close collaboration with the Chair and Vice-Chair and keeps them apprised of relevant information and significant issues in a timely fashion;
- d) Develops a strategic plan for approval by the Board of Directors and Implements short and long-range goals and objectives;
- e) Is responsible for the management of the operations of the Authority, including all Staff and programs of the Authority;
- f) Ensures resolutions of the Authority are implemented in a timely fashion:
- g) Develops and maintains effective relationships and ensures good communications with Participating Municipalities, federal and provincial government ministries/agencies, Indigenous communities, other conservation authorities, Conservation Ontario, stakeholders, community groups and associations;
- h) Serves as a signing officer for the Authority.

#### Deputy CAO

- a) Is an employee of the Authority
- b) Attends all meetings of the Board of Directors (and Executive Committee if applicable)

- c) Understands the responsibilities of the CAO and acts as CAO immediately upon the death, incapacity to act, absence or resignation of the CAO until such time as a new CAO is appointed or until the CAO resumes his/her duties
- d) Serves as a signing officer for the Authority
- e) Performs any duty delegated to him or her by the CAO

#### Secretary-Treasurer

- a) Is an employee of the Authority;
  - b) Fulfills the requirements of the Secretary-Treasurer as defined in the Act;
  - c) Attends all meetings of the Board of Directors (and Executive Committee, if applicable);
  - d) Is the custodian of the Corporate Seal;
  - e) Serves as a signing officer for the Authority.

#### 3. Absence of Chair and Vice-Chair

In the event of the absence of the Chair and Vice-Chair from any meeting, the Directors shall appoint an Acting Chair who, for the purposes of that meeting has all the powers and shall perform all the duties of the Chair.

#### 4. Maximum Time as Chair and Vice-Chair

The term of office for the Chair and Vice-Chair shall be limited to two (2) consecutive years unless otherwise decided by a resolution of the Board of Directors and approved by the Minister per Section 17 of the Act. §

The same maximum time period applies to an individual's role of Chair and/or Vice Chair of a Committee and to an individual's role as Chair and/or Vice Chair of an Advisory Board, unless otherwise decided by a resolution of the Board of Directors.

#### 5. Representatives to Conservation Ontario Council

The Authority may appoint up to three Representatives to Conservation Ontario Council ("Council"), designated as Voting Delegate and Alternate(s). Council will consist of the Voting Delegates appointed by each Member Conservation Authority. The Voting Delegate and Alternates shall be registered with Conservation Ontario annually.

#### 6. Election of Chair, Vice-Chair, Committee Members and Advisory Board Chairs

The election of the Chair and Vice-Chair, and the election or appointment by acclamation of Committee and Advisory Board members and Advisory Board chairs shall be held yearly at the Annual General Meeting and/or at the first Board meeting after the AGM, in accordance with the Authority's Procedures for Election and Appointment of Officers (Appendix 3).

Successors to the position of Chair and Vice-Chair shall be a director appointed by a different municipality to the incumbent, unless otherwise decided by a resolution of the Board of Directors and approved by the Minister per Section 17 of the Act.<sup>9</sup>

#### 7. Appointment of Auditor

The Board of Directors shall appoint an auditor for the coming year yearly at the annual meeting, in accordance with Section 38 of the Act.

#### 8. Financial Statements and Report of the Auditor

As required by Section 38 of the Act, the Authority shall cause its accounts and transactions to be audited annually by a person licensed under the *Public Accounting Act*, *2004*. The Board of Directors shall receive and approve the Audited Financial Statements and Report of the Auditor annually for the previous year yearly at the annual meeting.

No person shall be appointed an auditor of the HCA if the person is or during the preceding year was a member of the Board of Directors, or who has or during the preceding year had any direct or indirect interest in any contract or any employment with the HCA other than for services within his or her professional capacity.

The Authority shall forward copies of the Audited Financial Statements and Report of the Auditor to Participating Municipalities and the Minister in accordance with Section 38 of the Act and will make the Audited Financial Statements available to the public.

#### 9. Borrowing Resolution

If required, the Authority shall establish a borrowing resolution.

#### 10. Levy Apportionment Notice

The <u>levy municipal apportionment</u> due to the Authority from participating municipalities shall be communicated to those municipalities in accordance with the Act and any applicable Regulations.

#### 11. Signing Officers

Any two of the following Officers are designated and empowered to sign contracts, agreements and other documents on behalf of the HCA (with the exception of cheques or other documents effecting payment): Chair, Vice-Chair, Secretary-Treasurer, CAO, Deputy CAO, Director of Watershed Management Services, Director of Conservation Area Services. Approval of purchases shall be in accordance with the HCA Purchasing Policy. Cheques or other documents effecting payment must be signed by two of the following Officers: Chair, Vice-Chair, CAO and Secretary-Treasurer.

Signing authority that was authorized by any previous Administration Regulation or By-law is superseded by this by-law.

#### 12. Executive Committee

The Authority may appoint an Executive Committee at the first meeting of the Board of Directors each year in accordance with the Section 19 of the Act and Section B.1(c)(f) of this by-law.

#### 13. Advisory Boards and Other Committees

In accordance with Section 18(2) of the Act, the Authority shall establish such Advisory Boards as required by regulation and may establish such other Advisory Boards or committees as it considers appropriate to study and report on specific matters.

The Board of Directors shall approve the terms of reference for all such Advisory Boards and committees, which shall include the role, the frequency of meetings and the number of members required.

Resolutions and policies governing the operation of the Authority shall be observed in all Advisory Board and committee meetings.

Each Advisory Board or committee shall report to the Board of Directors, presenting any recommendations made by the Advisory Board or committee.

The dates of all Advisory Board and committee meetings shall be made available to all Directors of the Authority.

A list of standing Advisory Boards and committees that must be appointed, along with information about their mandates and proceedings, is contained in Appendix 4.

#### 14. Remuneration of Directors

The Authority shall establish a per-diem rate from time to time to be paid to Directors for attendance at General Meetings and Advisory Board or Committee meetings, and at such other business functions as may be from time to time requested by the Chair, through the Secretary-Treasurer. In addition, an honorarium may be approved by the Authority for the Chair and Vice-Chair as compensation for their additional responsibilities. A single per-diem will be paid for attendance at more than one meeting if they occur consecutively on the same day.

The Authority shall reimburse Directors' reasonable travel expenses incurred for the purpose of attending meetings and/or functions on behalf of the Authority. A per-kilometre rate to be paid for use of a personal vehicle shall be approved by Resolution of the Board of Directors from time-to-time. Requests for such reimbursements shall be submitted within a timely fashion and shall not exceed Canada Revenue Agency guidelines.

Members may opt out of receiving honorariums, per diems, and/or travel expense reimbursements. Such requests will be documented and retained in accordance with procedures for the management of records related to remuneration of Directors.

Remuneration of the Director appointed by the Minister as a representative of the agricultural sector is at the expense and discretion of the Province.

#### 15. Records Retention

The Authority shall keep full and accurate records including, but not limited to:

- a) Minutes of all meetings of the Authority, including registries of statements of interests in accordance with the *Municipal Conflict of Interest Act*;
- b) Assets, liabilities, receipts and disbursements of the Authority and Financial Statements and Reports of the Auditors;
- c) Human Resources Files for all employees and Directors as applicable;
- d) Workplace Health and Safety documents including workplace inspections, workplace accidents, investigations, etc.;
- e) Electronic Communications including material emails;
- f) Contracts and Agreements entered into by the Authority;
- g) Strategic Plans and other documents providing organizational direction;
- h) Projects of the Authority;
- i) Technical Studies and data gathered in support of Programs of the Authority;
- j) Legal Proceedings involving the Authority;

k) Incidents of personal injury or property damage involving the Authority and members of the public.

Such records shall be retained and protected in accordance with all applicable laws and any Records Retention Policy of the Authority as approved by the Board of Directors from time-to-time

#### 16. Records Available to Public

Records of the Authority shall be available to the public as required pursuant to the *Municipal Freedom of Information and Protection of Personal Privacy Act* (MFIPPA) and further to O. Regulation 400/22 Information Requirements.

The Chair and Vice Chair are designated as head of the Authority for the purposes of MFIPPA.

#### 17.By-law Review

In accordance with the Act, these by-laws shall be reviewed by the Authority at least every three years to ensure the by-laws are in compliance with the Act and any other relevant law. The Board of Directors shall review the by-laws on a regular basis to ensure best management practices in governance are being followed.

#### 18. By-law Available to Public

In accordance with the Act, the Authority shall make its by-laws available to the public on the Authority's website. By-laws shall also be available for review by any member of the public at the Authority's administration centre or provided in alternative formats, in accordance with the Accessibility for Ontarians with Disabilities Act, if requested by interested parties.

#### 19. Enforcement of By-laws and Policies

The Directors shall respect and adhere to all applicable by-laws and policies (for example, the Code of Conduct and Conflict of Interest Policy). The Authority may take reasonable measures to enforce its by-laws and policies, including the enforcement mechanisms under the *Municipal Conflict of Interest Act*.

The Board of Directors may enforce its regulations and policies in the following manner:

- a) If a Director is alleged not to have adhered to a by-law or policy, an investigation will be conducted into the alleged breach, unless the breach occurred at a Board of Directors meeting.
- b) The Director will be given a reasonable opportunity to respond to the allegation of breach.
- c) The findings of the investigation and the affected Director's response will be communicated to the Board of Directors in a closed meeting.
- d) The Board may debate the matter with the member present and participating unless, after reasonable notice, the member refuses to attend.
- e) The Board may choose to enforce the regulation or policy following debate by, among other things:
  - i. requesting adherence to the regulation or policy in future;
  - ii. imposing procedures to monitor adherence to the regulation or policy in future;
  - iii. if the member is Chair, Vice-Chair or chair of an Advisory Board or committee, removing the member from that position; or
  - iv. recommending to the municipality that appointed the member that the appointment be revoked and a replacement be appointed.

f) The appointing municipality or the appointing Minister shall be notified of the outcome of the investigation.

#### 20. Indemnification of Directors, Officers and Employees

The Authority undertakes and agrees to indemnify and save harmless its Directors, Officers and Employees and their heirs and legal representatives, respectively, from and against all costs, charges and expenses, including all amounts paid to settle an action or satisfy any judgement, reasonably incurred by any such Director, Officer or Employee in respect of any civil, criminal or administrative action or proceeding to which any such Director, Officer or Employee is made a party by reason of being a Director, Officer or Employee of the Authority (except in respect of an action by or on behalf of the Authority to procure a judgment in its favour) if;

- a) such Director, Officer or Employee acted honestly, in good faith with a view to the best interests of the Authority and within the scope of such Director's, Officer's or Employee's duties and responsibilities, and,
- in the case of a criminal or administrative action or proceeding that is enforced by a monetary penalty that such Director, Officer or Employee had reasonable grounds for believing that the conduct was lawful.

#### 21. Role of Hamilton Conservation Foundation

The Hamilton Conservation Foundation is a charitable corporation that raises awareness, funds and resources for the HCA. The Chair of the Hamilton Conservation Foundation shall occupy a non-voting seat on the Board of Directors of the HCA. The attendance of the Foundation Chair shall not be included in the determination of a quorum. The Foundation Chair shall receive a complete meeting package and shall be eligible to participate in all discussions at the Board of Directors meeting.

#### C. Meeting Procedures

The Meeting Procedures below governing the procedure of the Authority shall be observed in Executive Committee and Advisory Board meetings, as far as they are applicable, and the words Executive Committee or Advisory Board may be substituted for the word Authority as applicable.

#### 1. Rules of Procedure

In all matters of procedure not specifically dealt with under the Act and this By-law, the current edition of Robert's Rules of Order will be followed.

The Authority may choose to conduct its business as a committee of the whole.

#### 2. Notice of Meeting

The Board of Directors shall approve a schedule for regular meetings. The Secretary-Treasurer (or designate) shall send Notice of regular meetings to all Directors at least seven calendar days in advance of a meeting. Notice of all regular or special meetings of the Board of Directors or its committees shall be made available to the public as soon as possible after its delivery to Board of Directors.

Notice of any meeting shall indicate the time and place of that meeting and the agenda for the meeting.

All material and correspondence to be dealt with by the Authority at a meeting will be submitted to the Secretary-Treasurer (or designate) at least eight (8) days in advance of the meeting where it is to be dealt with if the material and correspondence is to be included in the published agenda. Items of correspondence not received in the timeframe specified above may be introduced at the meeting subject to approval by a majority of Directors present. To allow for circulation to Board members, correspondence should be received by 12pm EST the day before the board meeting or alternatively can be listed on the published agenda for the following meeting.

The Chair may, at his/her pleasure, call a special meeting of the Authority as necessary on seven calendar days' notice in writing or email. That notice shall state the business of the special meeting and only that business shall be considered at that special meeting. Any Director, with 50% support of the other Directors, may also request the Chair to call a meeting of the Authority and the Chair will not refuse.

The Chair of the Board, Chair of any respective committee or advisory board, or the Secretary-Treasurer (or designate) may, by notice in writing or email delivered to the Directors so as to be received by them at least 12 hours before the hour appointed for the meeting, postpone or cancel any scheduled meeting until the next scheduled date for the specific Board, Advisory Board or committee affected.

The Chair or the Secretary-Treasurer (or designate) may, if it appears that a storm or like occurrence will prevent the Directors from attending a meeting, postpone that meeting by advising as many Directors as can be reached. Postponement shall not be for any longer than the next regularly scheduled meeting date.

#### 3. Meetings Open to Public

Every meeting of the Board of Directors, Executive Committee and Advisory Boards, if applicable, shall be open to the public as per Section 15(3) of the Act, subject to the exceptions set out below.

HCA will live stream and/or make video recordings of all or part of its Board of Directors, Advisory Board or Committee meetings available to the public but it is not obliged to do so<sup>10</sup>.

Where in the discretion of the HCA, a meeting is live-streamed or recorded by video, at the start of the meeting the Secretary-Treasurer or designate shall advise all in attendance that the meeting is being recorded and/or livestreamed.

For open fully electronic or hybrid meetings that are live streamed, the public must be able to observe all that Members can hear and see at the meeting.

If a fully or hybrid telephone meeting of the Board of Directors is held, the Authority will provide means for the public to listen to the meeting. A meeting or part of a meeting may be closed to the public if the subject matter being considered is identified in the closed meeting section of the agenda or arises during a meeting requiring that it be closed to the public at the time that the matter is raised at a meeting, and if the subject matter being considered relates to:

- a) The security of the property of the Authority;
- b) Personal matters about an identifiable individual, including employees of the Authority;
- c) A proposed or pending acquisition or disposition of land by the Authority;
- d) Labour relations or employee negotiations;
- e) Litigation or potential litigation, including matters before administrative tribunals (e.g. Ontario Land Tribunal), affecting the Authority;
- f) Advice that is subject to solicitor-client privilege;
- g) A matter in respect of which the Board of Directors, Executive Committee, Advisory Board or committee or other body may hold a closed meeting under another act;
- h) information explicitly supplied in confidence to the Authority by Canada, a province or territory or a Crown agency of any of them;
- i) a trade secret or scientific, technical, commercial, financial or labour relations information, supplied in confidence to the Authority, which, if disclosed, could reasonably be expected to prejudice significantly the competitive position or interfere significantly with the contractual or other negotiations of a person, group of persons, or organization;
- j) a trade secret or scientific, technical, commercial or financial information that belongs to the Authority and has monetary value or potential monetary value; or
- k) a position, plan, procedure, criteria or instruction to be applied to any negotiations carried on or to be carried on by or on behalf of the Authority.

The Authority shall close a meeting if the subject matter relates to the consideration of a request under MFIPPA, and the designated head of the Authority for the purposes of MFIPPA is present.

Before holding a meeting or part of a meeting that is to be closed to the public, the Directors shall state by resolution during the open session of the meeting that there will be a meeting closed to the public and the general nature of the matter to be considered at the closed meeting. Once matters have been dealt with in a closed meeting, the Board of Directors shall reconvene in an open session.

When starting a closed session where Board members are attending by telephone or electronically, the Chair should take the following additional steps:

- a) Retake attendance and confirm that each Board member's connection is working;
- b) Confirm that all Board members are in a private setting where no other person can listen to the proceedings in the closed session; and
- c) Remind Board members that all confidentiality rules apply, and they must treat any documents and information with the same level of care that they would in a regular closed meeting.

The Board of Directors shall not vote during a meeting that is closed to the public, unless:

- a) the meeting meets the criteria outlined in this by-law to be closed to the public; and
- b) the vote is for a procedural matter or for giving directions or instructions to Officers, employees or agents of Authority.

Any materials presented to the Board of Directors during a closed meeting shall be returned to the Secretary-Treasurer or designate prior to departing from the meeting and shall be treated in accordance with the Authority's procedures for handling confidential material. If a closed meeting is held or attended by telephone or electronically, the Chair or Secretary-Treasurer may direct members to delete documents at the conclusion of the meeting rather than returning them to the Secretary-Treasurer or designate.

A meeting of the Authority, Executive Committee, Advisory Board or other committee may also be closed to the public if:

- a) the meeting is held for the purpose of educating or training the Directors, and
- b) at the meeting, no Director discusses or otherwise deals with any matter in a way that materially advances the business or decision-making of the Authority, the Executive Committee, Advisory Board or other committee.

#### 4. Agenda for Meetings

Authority Staff, under the supervision of the Secretary-Treasurer, shall prepare an agenda for all regular meetings of the Authority that shall include, but not necessarily be limited to, the following headings:

- a) Call to Order
- b) Declaration re Local Government Disclosure of Interest
- c) Approval of Agenda
- d) Delegations
- e) Consent Agenda
  - Applications
  - ii. Approval of Minutes of Previous Meeting
  - iii. Correspondence
- f) Foundation Chair Update
- g) Member Briefings
- h) Business Arising from the Minutes
- i) Reports from Budget & Administration Committee and Conservation Advisory Board
- j) Other Staff Reports/Memorandums
- k) New Business

- I) In-Camera Items
- m) Next Meeting
- n) Adjournment

The agenda for special meetings of the Authority shall be prepared as directed by the Chair.

The business of the Authority shall be taken up in the order in which it stands on the agenda unless otherwise decided by a Majority of those Directors present.

No Director shall present any matter to the Authority for its consideration unless the matter appears on the agenda for the meeting of the Authority or leave is granted to present the matter by the affirmative vote of a Majority of the Directors present.

Agendas for meetings shall be forwarded to all Directors at least seven calendar days in advance of the meeting. Such agendas shall be made available to the public on the Authority's website at the same time, unless the meeting is closed to the public in accordance with this by-law. Such agendas shall also be available in alternative formats, in accordance with the *Accessibility for Ontarians with Disabilities Act*, if requested by interested parties.

#### 5. Quorum

At any meeting of the Board of Directors, a quorum consists of one-half of the Directors appointed by the Participating Municipalities, except where there are fewer than six such Directors, in which case three such Directors constitute a quorum (per s.16(2) of the CAA). At any Executive Committee (if applicable), Advisory Board or committee meeting, a quorum consists of one-half of the Members of the Executive Committee (if applicable), Advisory Board or committee. NOTE: the Member appointed by the Minister to represent agricultural interests is not part of quorum.

If there is no quorum within one half hour after the time appointed for the meeting, the Chair for the meeting shall declare the meeting adjourned due to a lack of a quorum, or shall recess until quorum arrives, and the recording secretary shall record the names of the Directors present and absent.

If during an Authority or Advisory Board or Committee meeting a quorum is lost, then the Chair shall declare that the meeting shall stand recessed or adjourned, until the date of the next regular meeting or other meeting called in accordance with the provisions of this by- law.

Where the number of Directors who are disabled from participating in a meeting due to the declaration of a conflict of interest is such that at that meeting the remaining Directors are not of sufficient number to constitute a quorum, the remaining number of Directors shall be deemed to constitute a quorum, provided such number is not less than two.

#### 6. Debate

The Authority shall observe the following procedures for discussion/debate on any matter coming before it:

- a) A Director shall be recognized by the Chair prior to speaking;
- b) Where two or more Directors rise to speak, the Chair shall designate the Director who has the floor, who shall be the Director who in the opinion of the Chair was first recognized;
- c) All questions and points of discussion shall be directed through the Chair;
- d) Where a motion is presented, it shall be moved and seconded before debate;
- e) No Director shall speak more than once to the same question without leave from the Chair, except in explanation of a material part of the speech;

- f) No Director shall speak more than five minutes without leave of the Chair;
- g) Any Director may ask a question of the previous speaker through the Chair;
- h) The Director who has presented a motion, other than a motion to amend or dispose of a motion, may speak again to the motion immediately before the Chair puts the motion to a vote:
- i) When a motion is under debate, no motion shall be received other than a motion to amend, to defer action, to refer the question, to take a vote, to adjourn, or to extend the hour of closing the proceedings;
- j) When a motion is under consideration, only one amendment is permitted at a time.

#### 7. Matters of Precedence

The following matters shall have precedence over the usual order of business:

- a) a point of order;
- b) matter of privilege;
- c) a matter of clarification;
- d) a motion to suspend a rule of procedure or to request compliance with the rules of procedure;
- e) a motion that the question be put to a vote;
- f) a motion to adjourn.

#### 8. Directors' Attendance

The Authority shall provide a listing of Directors' attendance at scheduled meetings of the Authority to the Participating Municipalities at least annually.

Upon a Director's vacancy due to death, incapacity or resignation occurring in any office of the Authority, the Authority shall request the municipality that was represented by that Director appoint a Director replacement.

If a Director is unable to attend any meeting and wishes to bring any additional information or opinion pertaining to an agenda item to the Board of Directors, the Director shall address in writing or email to the Chair or Secretary-Treasurer such correspondence prior to the start of the meeting. The correspondence shall be read aloud by the Secretary-Treasurer without comment or explanations.

#### 9. Electronic Meetings and Participation

Electronic meetings are permitted and the Meeting Procedures identified in this by-law apply.

A Director may participate in a meeting of the Board of Directors by telephonic or electronic means that permits all participants to communicate adequately with each other during the meeting. A Director so participating in a meeting is deemed to be present at the meeting, and shall have the ability to chair a meeting, register a vote, be counted towards determining quorum, and participate in any portion of the meeting, including portions closed to the public.

Upon being apprised that an in-person, hybrid, or fully electronic meeting is interrupted and cannot proceed with its live stream, due to loss of connection, sound or video, the meeting will be recessed. If the live stream of a fully electronic meeting cannot be resumed, the meeting will be considered adjourned, with complete minutes for the meeting, including a record of the

interruption, to that point in time. The Board meeting will be rescheduled to another day or the next regularly scheduled meeting.

The Chair or the Chair's designate may administer a vote on a motion by electronic means if the motion is required on an urgent basis, or for any other reason as deemed necessary by the Chair or the Chair's designate. A deadline will be prescribed within which the votes must be cast, and the motion will pass by a majority vote. All votes by telephonic or electronic means shall be minuted in the same way as votes at in-person Board meetings.

#### 10. Delegations

Any person or organization who wishes to address the Authority may make a request in writing or email to the Secretary-Treasurer, or designate, using the prescribed "Request for Delegation" form. The request should include a brief statement of the issue or matter involved and indicate the name of the proposed speaker(s). If such request is received eight (8) business days in advance of a scheduled meeting, the delegation shall be listed on the published agenda.

Any person or organization requesting an opportunity to address the Authority but not having made a written request to do so in the timelines specified above, may appear before the meeting if approved by a Majority of Directors present. To allow for processing requirements, the request should be received by 12pm EST the day of the board meeting or alternatively can be listed on the published agenda for the following meeting. Except by leave of the Chair or appeal by the leave of the meeting, delegations shall be limited to one (1) speaker for not more than 10 minutes.

Speakers will be requested not to repeat what has been said by previous speakers at the meeting. A returning delegation will only be allowed to speak again if new, relevant information has become available since their previous presentation. The Chair may choose to end a returning delegation's presentation if, in the opinion of the Chair, the new information being presented is not relevant to a decision facing the Board of Directors.

Where appropriate, the Chair may advise those in attendance at a Board of Directors meeting: (a) to respect reasonable rules of decorum in their remarks; and (b) that no endorsement by the HCA of a delegate's statements may be implied or inferred from the communication of the statements during the course of the Board of Directors meeting, or on account of the HCA having granted permission to the delegate to make a presentation at the Board of Directors meeting. The Chair may expel any delegate or member of the public from the meeting who does not respect reasonable rules of decorum.

A delegation may appear at a meeting of the Board of Directors by telephonic or electronic means. The Secretary-Treasurer, or designate, will liaise with the leader of the delegation to plan for their attendance by telephone or electronically.

Where in the discretion of the HCA a Board of Directors meeting is live-streamed and/or recorded, notice to this effect, and regarding the purpose of the live streaming or recording, shall be given to those attending the meeting, either at the time of the meeting or in advance of the meeting.

# 11. Meeting Schedule and Annual General Meeting

Subject to the right of the Board to set a different meeting schedule or to change the date of a meeting, and the right of the Chair to call a special meeting, the Board will meet 10 times per year beginning at 6:00 p.m. on the first Thursday of the months of February, March, April, May, June, July, September, October, November and December.

The Annual General Meeting shall be the February meeting each year. The date of the meeting may be adjusted to allow for consideration for timing of municipal elections and corresponding

municipal and citizen appointments, or for other considerations as may be required. The Annual General Meeting shall include the following items on the agenda, in addition to the normal course of business:

- a) Appointment of the auditor for the upcoming year
- b) Election of Officers
- c) Board meeting schedule
- d) Voting delegates to Conservation Ontario
- e) Director participation on any Committees

### 12. Voting

In accordance with Section 16 of the Act:

- a) each Director is entitled to one vote, and
- b) a Majority vote of the Directors present at any meeting is required upon all matters coming before the meeting.

Where a member has been appointed by the Minister as a representative of the agricultural sector, the member shall not vote on a resolution to enlarge an authority's area of jurisdiction, a resolution to amalgamate the Authority with another conservation authority, a resolution to dissolve the Authority or a resolution related to any budgetary matter.

If any Director who is qualified to vote abstains from voting, they shall be deemed to have voted neither in favour nor opposed to the question, which will not alter the number of votes required for a Majority.

On a tie vote, the motion is lost.

Interrelated motions shall be voted on in the order specified in Robert's Rules of Order.

Unless a Director requests a recorded vote, a vote shall be by a show of hands or such other means as the Chair may call. No question shall be voted upon more than once at any meeting, unless a recorded vote is requested.

If a Director present at a meeting at the time of the vote requests immediately before or after the taking of the vote that the vote be recorded, each Director present taken by alphabetical surname with the Chair voting last, except a Director who is disqualified from voting by any Act, shall announce his or her vote openly answering "yes" or "no" to the question, and the Secretary-Treasurer shall record each vote.

Where a question under consideration contains more than one item, upon the request of any Director, a vote upon each item shall be taken separately.

Except as provided in Section B, Paragraph 6 of this By-law (Election of Chair and Vice-Chair), no vote shall be taken by ballot or by any other method of secret voting, and every vote so taken is of no effect.

#### 13. Notice of Motion

Written notice of motion to be made at an Authority, Executive Committee, Advisory Board or committee meeting may be given to the Secretary-Treasurer by any Director of the Authority not less than 10 calendar days prior to the date and time of the meeting and shall be forthwith placed on the agenda of the next meeting. The Secretary-Treasurer shall include such notice of motion in full in the agenda for the meeting concerned.

Recommendations included in reports of Advisory Boards or committees that have been included in an agenda for a meeting of the Board of Directors or Executive Committee (if applicable), shall constitute notice of motion for that meeting.

Recommendations included in Staff reports that have been included in an agenda for a meeting of the Board of Directors or Executive Committee (if applicable), shall constitute notice of motion for that meeting.

Notwithstanding the foregoing, any motion or other business may be introduced for consideration of the Authority provided that it is made clear that to delay such motion or other business for the consideration of an appropriate Advisory Board or committee would not be in the best interest of the Authority and that the introduction of the motion or other business shall be upon an affirmative vote of a Majority of the Directors of the Authority present.

#### 14. Motion to Reconsider

If a motion is made to reconsider a previous motion, a two-thirds majority vote shall be required in order for reconsideration to take place. If a motion to reconsider is passed, the original motion shall then be placed on the agenda at a future meeting to be debated and voted upon, and the result of that vote, based on a simple Majority, shall supersede.

#### 15. Duties of the Meeting Chair

It shall be the duty of the Chair, with respect to any meetings over which he/she presides, to:

- a) Preserve order and decide all questions of order, subject to appeal; and without argument or comment, state the rule applicable to any point of order if called upon to do so;
- b) Ensure that the public in attendance does not in any way interfere or disrupt the proceedings of the Directors;
- c) Receive and submit to a vote all motions presented by the Directors, which do not contravene the rules of order or regulations of the Authority;
- d) Announce the results of the vote on any motions so presented;
- e) Adjourn the meeting when business is concluded.

#### 16. Conduct of Directors

Directors shall maintain a high standard for conduct and at all times comply with applicable laws and the Authority's Code of Conduct (Appendix 1).

No Director at any meeting of the Authority shall:

- a) Speak in a manner that is discriminatory in nature based on an individual's race, ancestry, place of origin, citizenship, creed, gender, sexual orientation, age, colour, marital status, family status or disability;
- b) Leave their seat or make any noise or disturbance while a vote is being taken or until the result is declared:
- Interrupt a Director while speaking, except to raise a point of order or a question of privilege;
- d) Speak disrespectfully or use offensive words against the Authority, the Directors, Staff, or any member of the public;
- e) Speak beyond the question(s) under debate;
- f) Resist the rules of order or disobey the decision of the Chair on the questions or order or practices or upon the interpretation of the By-laws.

#### 17. Minutes of Meetings

The Secretary-Treasurer shall undertake to have a recording secretary in attendance at meetings of the Authority, the Executive Committee and each Advisory Board or committee. The recording secretary shall make a record in the form of minutes of the meeting proceedings and in particular shall record all motions considered at the meeting.

If a recording secretary is not present in a closed session, the Secretary-Treasurer shall take notes of any direction provided, for endorsement by the Chair and Vice-Chair. Original copies of confidential minutes are approved and signed by the Chair and filed separately from non-confidential minutes.

Minutes of all meetings shall include the time and place of the meeting and a list of those present and shall state all motions presented together with the mover and seconder and voting results.

A recording of a Board of Directors meeting, if one exists, is not an official record of that meeting. The official record of the meeting shall consist solely of the Minutes approved by the Board of Directors. As the purpose of the recording is administrative, the recordings will be disposed of once they have served that purpose, per HCA's Records Retention. Schedule.

The Secretary-Treasurer or designate shall include draft minutes of the previous meeting available to each Director of the Authority at the same time as agendas for the next meeting are distributed.

After the minutes have been approved by resolution, original copies shall be signed by the Secretary-Treasurer and copies of all non-confidential minutes shall be posted on the Authority's website. Such minutes shall also be available for review by any member of the public at the Authority's administration centre or provided in alternative formats, in accordance with the Accessibility for Ontarians with Disabilities Act, if requested by interested parties.

# E. Appendices to the Administrative By-law

## **Appendix 1 - Code of Conduct**

#### 1. Background

The Hamilton Conservation Authority demands a high level of integrity and ethical conduct from its Board of Directors. The Authority's reputation has relied upon the good judgement of individual Directors. A written Code of Conduct helps to ensure that all Directors share a common basis for acceptable conduct. Formalized standards help to provide a reference guide and a supplement to legislative parameters within which Directors must operate. Further, they enhance public confidence that Directors operate from a base of integrity, justice and courtesy.

The Code of Conduct is a general standard. It augments the laws which govern the behaviour of Directors, and it is not intended to replace personal ethics.

This Code of Conduct will also assist Directors in dealing with confronting situations not adequately addressed or that may be ambiguous in Authority resolutions, regulations, or policies and procedures. Additionally, the agricultural representative appointed by the Minister will be required to follow the provincial ethical framework set out for government public appointees in the Management Board of Cabinet's Agencies and Appointments Directive.

#### 2. General

All Directors, whether municipal councillors or appointed representatives of a municipality, or whether appointed by the Minister as a representative of the agricultural sector, are expected to conduct themselves in a manner that reflects positively on the Authority.

All Directors shall serve in a conscientious and diligent manner. No Director shall use the influence of office for any purpose other than for the exercise of his/her official duties.

It is expected that Directors adhere to a code of conduct that:

- a) upholds the mandate, vision and mission of the Authority;
- b) considers the Authority's jurisdiction in its entirety, including their appointing municipality;
- c) respects confidentiality;
- d) approaches all Authority issues with an open mind, with consideration for the organization as a whole:
- e) exercises the powers of a Director when acting in a meeting of the Authority;
- f) respects the democratic process and respects decisions of the Board of Directors, Executive Committee, Advisory Boards and other committees;
- g) declares any direct or indirect Pecuniary Interest or conflict of interest when one exists or may exist; and
- h) conducts oneself in a manner which reflects respect and professional courtesy and does not use offensive language in or against the Authority or against any Director or any Authority Staff.

#### 3. Gifts and Benefits

Directors shall not accept fees, gifts, hospitality or personal benefits that are connected directly or indirectly with the performance of duties.

#### 4. Confidentiality

The Directors shall be governed at all times by the provisions of the *Municipal Freedom and Information and Protection of Privacy Act*.

All information, documentation or deliberations received, reviewed, or taken in a closed meeting are confidential.

Directors shall not disclose or release by any means to any member of the public, either in verbal or written form, any confidential information acquired by virtue of their office, except when required by law to do so.

Directors shall not permit any persons, other than those who are entitled thereto, to have access to information which is confidential.

In the instance where a Director vacates their position on the Board of Directors they will continue to be bound by MFIPPA requirements.

Particular care should be exercised in protecting information such as the following:

- a) Human Resources matters;
- b) Information about suppliers provided for evaluation that might be useful to other suppliers;
- c) Matters relating to the legal affairs of the Authority;
- d) Information provided in confidence from an Aboriginal community, or a record that if released could reasonably be expected to prejudice the conduct of relations between an Aboriginal community and the Authority;
- e) Sources of complaints where the identity of the complainant is given in confidence;
- f) Items under negotiation;
- g) Schedules of prices in tenders or requests for proposals;
- h) Appraised or estimated values with respect to the Authority's proposed property acquisitions or dispositions;
- i) Information deemed to be "personal information" under MFIPPA.

The list above is provided for example and is not exhaustive.

### 5. Use of Authority Property

No Director shall use for personal purposes any Authority property, equipment, supplies, or services of consequence other than for purposes connected with the discharge of Authority duties or associated community activities of which the Authority has been advised.

#### 6. Work of a Political Nature

No Director shall use Authority facilities, services or property for his/her election or re-election campaign to any position or office within the Authority or otherwise.

#### 7. Conduct at Authority Meetings

During meetings of the Authority, Directors shall conduct themselves with decorum. Respect for delegations and for fellow Directors requires that all Directors show courtesy and not distract from the business of the Authority during presentations and when others have the floor.

#### 8. Influence on Staff

Directors shall be respectful of the fact that Staff work for the Authority as a whole and are charged with making recommendations that reflect their professional expertise and corporate perspective, without undue influence.

#### 9. Business Relations

No Director shall borrow money from any person who regularly does business with the Authority unless such person is an institution or company whose shares are publicly traded and who is regularly in the business of lending money.

No Director shall act as a paid agent before the Authority, the Executive Committee or an Advisory Board or committee of the Authority, except in compliance with the terms of the *Municipal Conflict of Interest Act*.

#### 10. Encouragement of Respect for the Authority and its Regulations

Directors shall represent the Authority in a respectful way and encourage public respect for the Authority and its Regulations.

#### 11. Harassment

It is the policy of the Authority that all persons be treated fairly in the workplace in an environment free of discrimination and of personal and sexual harassment. Harassment of another Director, Staff or any member of the public is misconduct. Directors shall follow the Authority's Harassment Policy as approved from time-to-time.

Examples of harassment that will not be tolerated include: verbal or physical abuse, threats, derogatory remarks, jokes, innuendo or taunts related to an individual's race, religious beliefs, colour, gender, physical or mental disabilities, age, ancestry, place of origin, marital status, source of income, family status or sexual orientation. The Authority will also not tolerate the display of pornographic, racist or offensive signs or images; practical jokes that result in awkwardness or embarrassment; unwelcome invitations or requests, whether indirect or explicit and any other prohibited grounds under the provisions of the *Ontario Human Rights Code*.

#### 12. Breach of Code of Conduct

Should a Director breach the Code of Conduct, they shall advise the Chair and Vice-Chair, with a copy to the Secretary Treasurer, as soon as possible after the breach.

Should a Director allege that another Director has breached the Code of Conduct, the said breach shall be communicated to the Chair, with a copy to the Secretary-Treasurer, in writing. In the absence of the Chair, or if a Director alleges that the Chair has breached the Code of Conduct, the said breach shall be communicated to the Vice-Chair, with a copy to the Secretary-Treasurer, in writing.

Should a member of the public or a municipality allege that a Director has breached the Code of Conduct, the party making the allegation will be directed to follow the notification procedure outlined above.

Any breach, or alleged breach, of the Code of Conduct shall be investigated in accordance with the Enforcement of By-laws and Policies procedure outlined or referred to in the Authority's Administrative By-law.

## **Appendix 2 - Conflict of Interest**

#### 1. Municipal Conflict of Interest Act

The Authority Directors commit themselves and the Authority to ethical, businesslike, and lawful conduct when acting as the Board of Directors. The Authority and the Directors are bound by the *Municipal Conflict of Interest Act*. This appendix to the by-law is intended to assist Directors in understanding their obligations. Directors are required to review the *Municipal Conflict of Interest Act* on a regular basis.

Additionally, the agricultural representative appointed by the Minister will be required to follow the provincial ethical framework set out for government public appointees in the Management Board of Cabinet's Agencies and Appointments Directive.

#### 2. Disclosure of Pecuniary Interest

Where a Director, either on his or her own behalf or while acting for, by, with or through another, has any Pecuniary Interest, direct or indirect, in any matter and is present at a meeting of the Authority, Executive Committee, Advisory Board or committee at which the matter is the subject of consideration, the Director:

- a) shall, prior to any consideration of the matter at the meeting, disclose the Pecuniary Interest and the general nature thereof;
- b) shall not take part in the discussion of, or vote on any question in respect of the matter;
- c) shall not attempt in any way whether before, during or after the meeting to influence the voting on any such question; and
- d) shall file a written statement of the Conflict of Interest and its general nature with the Secretary-Treasurer or designate.

#### 3. Chair's Conflict of Interest or Pecuniary Interest

Where the Chair of a meeting discloses a conflict of interest with respect to a matter under consideration at a meeting, another Director shall be appointed to chair that portion of the meeting by Resolution.

#### 4. Closed Meetings

Where a meeting is not open to the public, a Director who has declared a conflict of interest shall leave the meeting for the part of the meeting during which the matter is under consideration. The Chair of the meeting or CAO will at that point direct the member to recuse themselves and leave the room. The member will be recalled when the subject matter of the conflict is concluded.

#### 5. Director Absent

Where the interest of a Director has not been disclosed by reason of their absence from the particular meeting, the Director shall disclose their interest and otherwise comply at the first meeting of the Authority, Executive Committee, Advisory Board or Committee, as the case may be, attended by them after the particular meeting.

#### 6. Disclosure Recorded in Minutes

The recording secretary shall record in reasonable detail the particulars of any disclosure of conflict of interest or Pecuniary Interest made by Directors and whether the Director withdrew from the discussion of the matter. Such record shall appear in the minutes/notes of that particular meeting of the Board of Directors, Executive Committee, Advisory Board or committee, as the case may be.

#### 6B. Registry Maintained for Public Inspection

The Authority shall maintain a registry in which shall be kept:

- a) A copy of each statement filed under Section 2d) of this policy; and,
- b) A copy of each declaration recorded in the Minutes.

The registry shall be available for public inspection.

#### 7. Breach of Conflict of Interest Policy

Should a Director breach the Conflict of Interest Policy, they shall advise the Chair and Vice-Chair, with a copy to the Secretary Treasurer, as soon as possible after the breach.

Should a Director allege that another Director has breached the Conflict of Interest Policy, the said breach shall be communicated to the Chair, with a copy to the Secretary Treasurer, in writing. In the absence of the Chair, or if a Director alleges that the Chair has breached the Conflict of Interest Policy, the said breach shall be communicated the Vice-Chair, with a copy to the Secretary-Treasurer, in writing.

Should a member of the public or a municipality allege that a Director has breached the Conflict of Interest Policy, the party making the allegation will be directed to follow the notification procedure outlined above.

Any breach, or alleged breach, of the Conflict of Interest Policy shall be investigated in accordance with the Enforcement of By-laws and Policies procedure outlined or referred to in the Authority's Administrative By-law.

## **Appendix 3 - Procedure for Election and Appointment of Officers**

#### 1. Voting

Except in the case of appointments by acclamation of Directors to sit as members of the Budget and Administration Committee or the Conservation Advisory Board, voting shall be by secret ballot. No Directors may vote by proxy.

#### 2. Acting Chair

The Board of Directors shall appoint a person, who is not a voting Director, as Acting Chair or Returning Officer, for the purpose of Election of Officers.

#### 3. Scrutineer(s)

The appointment of one or more scrutineers is required for the purpose of counting ballots, should an election be required. All ballots shall be destroyed by the scrutineers afterwards. The Acting Chair shall call a motion for the appointment of one or more persons, who are not Directors of the Authority, to act as scrutineers. A Director, who will not stand for election, may be appointed as an additional scrutineer if requested.

# 4. Appointment by acclamation of Directors to sit as members of Committees and Advisory Boards

At the Annual General Meeting each year, Directors may nominate themselves to be one of the three Director members of the Budget and Administration Committee or the Conservation Advisory Board. A sign-up sheet for Directors wishing to self-nominate shall be available at the Annual General Meeting for this purpose. If more Directors sign up for the Budget and Administration Committee or Conservation Advisory Board than the number of vacancies, there shall be an election for those positions at the next Board meeting following the Annual General Meeting. If the number of Directors who sign up is less than or equal to the number of vacancies, the Acting Chair shall declare those positions filled by acclamation. Any remaining vacancies may be filled by acclamation or election at any subsequent Board meeting.

#### 5. Election Procedures

The Acting Chair shall advise the Directors that the election will be conducted in accordance with the Act and the HCA Administrative By-law Section B: Governance, subsection 4 'Maximum Term for Chair and Vice Chair(s)', as follows:

- a) The elections at the Annual General Meeting shall be conducted in the following order:
  - Election of the Chair, who shall be a Director appointed by a participating Municipality to the Authority and serve as a member of the Budget and Administration Committee.
  - ii. Election of the Vice-Chair, who shall be a Director appointed by a participating Municipality to the Authority and serve as Chair of the Budget and Administration Committee
  - iii. If applicable, appointment by acclamation of three Budget and Administration Committee members, who shall be Directors of the Authority.
  - iv. If applicable, appointment by acclamation of three Conservation Advisory Board members, who shall be Directors of the Authority.
  - v. Election of Chair of the Conservation Advisory Board, who shall be a Director of the Authority.

- b) The elections at the Board meeting immediately following the Annual General Meeting (if made necessary as a result of more Directors having self-nominated for the positions than the number of vacancies available on the Budget and Administration Committee and the Conservation Advisory Board), shall be conducted in the following order:
  - i. Election of up to three Budget and Administration Committee members, who shall be Directors of the Authority.
  - ii. Election of up to three Conservation Advisory Board members, who shall be Directors of the Authority.
- The Acting Chair shall ask for nominations to each position that is to be the subject of an election at the Annual General Meeting or at the Board meeting immediately following;
- d) Only current Directors of the Authority who are present may vote;
- e) Nominations shall be called three (3) times and will only require a mover;
- f) The closing of nominations shall require both a mover and a seconder;
- g) Each Director nominated shall be asked to accept the nomination. The Director must be present to accept the nomination unless the Director has advised the Secretary-Treasurer in writing or by email in advance of the election of their willingness to accept the nomination.

#### If one Nominee:

h) If only one nominee the individual shall be declared into the position by acclamation.

#### If More than One Nominee:

- i) In the event of an election, each nominee shall be permitted not more than five minutes to speak for the office, in the order of the alphabetical listing by surnames.
- j) Upon the acceptance by nominees to stand for election to the position of office, ballots shall be distributed to the Directors by the scrutineers for the purpose of election and the Acting Chair shall ask the Directors to write the name of one individual only on the ballot.
- k) The scrutineers shall collect the ballots, leave the meeting to count the ballots, return and advise the Acting Chair who was elected with more than 50% of the vote.

A Majority vote shall be required for election. If there are more than two nominees, and upon the first vote no nominee receives the Majority required for election, the name of the person with the least number of votes shall be removed from further consideration for the office and new ballots shall be distributed. In the case of a vote where no nominee receives the Majority required for election and where two or more nominees are tied with the least number of votes, a special vote shall be taken to decide which one of such tied nominees' names shall be dropped from the list of names to be voted on in the next vote.

Should there be a tie vote between two remaining candidates, new ballots shall be distributed and a second vote held. Should there still be a tie after the second ballot a third vote shall be held. Should there be a tie after the third vote, the election of the office shall be decided by lot drawn by the Acting Chair or designate.

#### **Appendix 4 - Committees and Advisory Boards**

#### 1. Creation, Role and Powers

<u>Establishment by the Board of Directors</u>: Committees and Advisory Boards may be established by the Board of Directors from time to time. They may be permanent or ad hoc.

<u>Role</u>: Committees and Advisory Boards are established by the Board of Directors to help the Board do its job. They assist the Board by:

- (a) investigating, reviewing and making recommendations to the Boards;
- (b) preparing policy alternatives and identifying implications for Board deliberation; and
- (c) considering and recommending details and actions on programs, projects, etc., within their terms of reference.

<u>Powers</u>: Committees and Advisory Boards have advisory powers only unless other powers are specifically delegated to them by the Board of Directors in writing. Committees and Advisory Boards may not speak or act for the Board except when formally given such authority for specific and time-limited purposes. They do not spend funds or approve policy. Powers will be carefully stated in order not to conflict with authority delegated to the CAO. In keeping with the Board's broader focus, Committees and Advisory Boards will normally not have direct dealings with current Staff operations, and will not delegate directly to Staff.

<u>Composition</u>: Committees are composed of sitting members of the Board of Directors. Advisory Boards are composed of sitting members of the Board of Directors and citizens selected by the Advisory Board Chair for their knowledge or expertise in an area of concern to the specific Advisory Board.

#### 2. Current Committee and Advisory Board Structure

The HCA currently has one standing Committee and one Advisory Board:

- (a) the Budget and Administration Committee; and
- (b) the Conservation Advisory Board.

#### 3. Terms of Reference

<u>Board to Set Terms of Reference</u>: The Board of Directors shall set terms of reference for each Committee and Advisory Board. The terms of reference should describe:

- (a) the name of the Committee or Advisory Board;
- (b) the specific functions, roles and objectives of the Committee or Advisory Board;
- (c) the number of members including, if applicable, the minimum and maximum number of members, and the number of members who must be Directors;
- (d) the term of membership;
- (e) the total maximum time period that a person who is not a Director may remain a member, if applicable:
- (f) the manner of appointment of members;
- (g) qualifications for membership, if applicable; and
- (h) any details regarding meeting procedure that may differ from the procedures applicable to Board meetings.

#### 4. Meeting Procedure

<u>Board Procedure Applies</u>: The regulations governing the procedure of the Board of Directors shall be observed in Committee and Advisory Board meetings, as far as they are applicable, unless varied by the terms of reference of the Committee or Advisory Board in question.

<u>Calling Meetings</u>: Each Committee and Advisory Board shall meet at such time and place as its Chair shall decide under the general direction of the Board of Directors.

<u>Notice of Meetings</u>: Notice of Committee and Advisory Board meetings shall be conveyed to all members at least 5 days prior to the date of the meeting.

Quorum: A quorum of a Committee or Advisory Board shall not be less than one half of its voting members.

Meetings Public: All Committee and Advisory Board meetings are open to the public.

<u>In Camera Business</u>: When a Committee or Advisory Board deals with "in camera" items, the chair of that Committee Advisory Board must report back to the next Board of Directors meeting providing background information, a summary of any discussion and any recommendations. The Board of Directors may receive such reports "in camera" as needed.

#### 5. Minutes of Meetings

<u>Minutes to be Recorded</u>: The minutes of all meetings of the Budget and Administration Committee shall be recorded by the Secretary-Treasurer or his/her designate, and the minutes of all other Committee and Advisory Board meetings shall be recorded by HCA Staff members as designated by the CAO.

<u>Circulation of Minutes</u>: The minutes of Committee and Advisory Board meetings shall be circulated by the secretary of the meeting at least five (5) days prior to the next meeting of the Committee or Advisory Board. The minutes, subject to any amendments approved at the meeting, shall be adopted by motion.

#### 6. Budget and Administration Committee

Members: The Budget and Administration Committee consists of five members of the Board of Directors. The Chair and Vice-Chair of the Board are designated members of the B&AC. Three other members of the Board shall be members of the B&AC. Directors may nominate themselves to be a member of the B&AC, by signing up for the role at the Annual General Meeting each year. If more than three members of the Board (in addition to the Chair and Vice-Chair of the Board) sign up, there shall be an election at the Board meeting following the Annual General Meeting.

Functions: The Budget and Administration Committee is responsible for the following functions:

- (a) Including a "Declaration re Local Government Disclosure of Interest" in its agenda, immediately following the "Chair's Remarks";
- (b) Receiving delegations;
- (c) Reviewing and receiving information memorandums and reports related to topics including but not limited to the following:
  - Expenditure report (Vendor Listing)
  - WSIB Incidents
  - Operating budgets
  - Capital budgets
  - Mileage rates
  - Per diems and honorariums
  - Fee schedules:

- (d) Recommending the acquisition and/or sale of land;
- (e) Considering matters "in camera", as per section C.3 in this by-law;
- (f) Investigating, reviewing and making recommendations to the Board of Directors on budget matters, including in particular:
  - (i) Reviewing recommendations of Staff on upcoming capital and operating budgets and making recommendations on same;
  - (ii) Reviewing and making recommendations on procedures for obtaining municipal, provincial, federal and private funding;
  - (iii) Reviewing and making recommendations on alternate financing methods, i.e. the issuance of debentures, mortgages, etc.;
  - (iv) Reviewing and making recommendations on the Auditor's annual report;
  - (v) Where appropriate, receiving delegations on behalf of the Board of Directors, and making recommendations thereon.
- (g) Investigating, reviewing and making recommendations to the Board of Directors on insurance matters, including in particular:
  - (i) Reviewing and making recommendations on current HCA insurance contracts;
  - (ii) Reviewing and making recommendations on insurance claims pertaining to the overall HCA operation and jurisdiction.
- (h) Investigating, reviewing and making recommendations to the Board of Directors on personnel related matters, including in particular:
  - (i) Reviewing Staff requirements and making recommendations on new permanent positions;
  - (ii) Advertising for new permanent positions, interviewing applicants and recommending a final selection for Salary Classification S11 and greater;
  - (iii) Reviewing and making recommendations on step progression or merit increases, and cost of living increases;
  - (iv) Reviewing and making recommendations on overall salary adjustments and reclassifications:
  - (v) Reviewing the HCA Personnel Policy and fringe benefit programs, and making recommendations on any required changes with a budget impact;
  - (vi) Reviewing and making recommendations on members' per diems, honorariums, etc.
- (i) Investigating, reviewing and making recommendations to the Board of Directors on matters pertaining to the negotiation of the various conservation area concession operation contracts and rental agreements.
- (j) Investigating and making recommendations on such other matters as assigned by the Board of Directors, and such matters as may arise from time to time which require some pre-consideration before being brought to the Board of Directors for a final decision.

Governance: The B&AC will oversee and make recommendations to the Board of Directors regarding the good corporate governance of the HCA. For this purpose, the mandate of the B&AC is to: (a) consider and report annually to the Board of Directors on governance issues that have arisen in the past year, including making recommendations, if appropriate, for amendments

to this Administrative By-Law, and (b) conduct a comprehensive review of corporate governance every three years and report to the Board of Directors on the results, including making recommendations, if appropriate, for amendments to this Administrative By-Law. The Board shall decide, following receipt of the B&AC's report, whether action is appropriate or required to ensure the continued good corporate governance of the HCA.

#### 7. Executive Committee

<u>Discretion to Create Executive Committee</u>: The Board of Directors may delegate all or any of its power to an Executive Committee (if applicable), except:

- (a) the termination of the services of the Secretary-Treasurer
- (b) the power to raise money, and
- (c) the power to enter into contracts or agreements other than such contracts or agreements as are necessarily incidental to the works approved by the Board of Directors.

<u>No Executive Committee</u>: In 1983, the HCA decided to abandon its Executive Committee. All powers therefore rest with the Board of Directors.

#### 8. Conservation Advisory Board

<u>Functions</u>: The Conservation Advisory Board (CAB) will consider, review and make recommendations on:

- (a) Specific projects as requested annually or as identified by the Board of Directors
- (b) Specific projects and programs identified by HCA staff including but not limited to the following:
  - (i) Conservation area master development plans
  - (ii) Development of new volunteer engagement programs and friends organizations that assist HCA in conservation area programs and projects
  - (iii) Policies, protocols and memorandums of agreement/understanding that do not have a budget impact
  - (iv) Long range strategies and plans, watershed and sub-watershed plans and provincial or federal environmental assessments, among other matters.
  - (v) Large-scale natural heritage enhancement projects, both on Authority owned and managed lands as well as private lands.
  - (vi) Cultural heritage projects for HCA conservation areas and for any buildings or structures owned by the Authority for designation under the terms of the Ontario Heritage Act, R.S.O, 1990.
  - (vii) The continued development and enhancement of the Hamilton Watershed Stewardship Program which includes programs on private and conservation area lands designed to improve the conservation, management and restoration of watershed resources and improvement of water quality.
  - (ix) Large-scale, major private and public sector projects which have the potential for major environmental impacts on watershed resources.
  - (x) HCA reports and studies for engineering and water management projects and for comprehensive watershed and subwatershed management projects and plans, among other matters.

- (xi) The establishment of subcommittees to the CAB, to deal with specific policy or program matters as appropriate, or to sit as members of HCA-established project Steering Committees and to bring recommendations to the CAB for consideration and final recommendation.
- (c) Receive information and updates on conservation area operations including annual attendance figures, events and annual membership pass program

Membership: The CAB shall be composed of voting members as follows:

- Citizens: up to 8 appointed members of the community at large, with a minimum of 6
- Board of Directors: up to 3 members of the Board

<u>Chair & Vice Chair of CAB</u>: One of the Directors shall serve as Chair of the CAB and a Vice-Chair shall be selected by the CAB members which can be a citizen or Director.

<u>Ex Officio Members</u>: The Chair and Vice Chair of the Board of Directors are ex-officio non-voting members of CAB. They are invited but not required to attend meetings of CAB. If in attendance they are not counted when determining quorum.

#### Terms of Appointment:

- Citizen members: citizen appointments to CAB will be for a maximum period of 8
  consecutive years, with these positions being noted as 4 year appointments with an option
  for an additional one 4-year term at renewal. Citizen appointments will be staggered to
  ensure there is not a significant amount of membership turnover in any given year to ensure
  continuity and knowledge over time.
- After serving for the two terms noted above, a citizen member with continued interest may apply for future vacancies provided the member has taken a minimum of a one year break.
- Directors: appointments of Board of Director members to the CAB are for one year terms and renewed at the Annual General Meeting. Directors may nominate themselves to be a member of CAB, by signing up for the role at the Annual General Meeting. If more than three members of the Board sign up, there shall be an election at the Board meeting following the Annual General Meeting.

#### Citizen Recruitment & Selection:

#### Recruitment & Vacancies for Citizen Members

When new citizen members are required a "Notice of Vacancy" will be prepared by the HCA staff and distributed through HCA communication channels which includes, but is not limited to, posting on the HCA website and social media. This document will include general information regarding committee functions and a link to the terms of reference.

A vacancy occurs when a citizen member resigns, vacates a position at their maximum term length or when their resignation is requested by the Chair.

All applicants must submit an expression of interest which includes a cover page and resume.

Selected applicants must attend an interview. The Chair and Vice chair of CAB (or designate) will form the interview committee along with one HCA staff person as designated by the CAO.

The citizen member(s) selected by the interview committee will be endorsed and approved by a report to the next Board of Directors meeting.

#### Eligibility for Citizen Members

Appointment to CAB will be made providing adherence with the following eligibility requirements:

- Citizen members must live within the HCA watershed
- Citizen members must possess experience and/or expertise with environmental/natural resource issues and/or outdoor recreation/operations, which may include volunteer experience
- While applicants who meet the above eligibility criteria are encouraged to apply, applicants with demonstrated participation in groups or initiatives with goals relevant to the Conservation Advisory Board will be preferred.

Active participation in the CAB meetings is expected of all citizen members. Active participation may refer to both meeting attendance and/or engagement. Members who miss three consecutive meetings without justified absence may be retired from the committee at the discretion of the CAB Chair.

<u>Meetings</u>: Regular meetings of the CAB will be scheduled on a bi-monthly basis, up to 6 meetings per year (currently meetings are proposed as February, April, June, August, October, and December) or at the discretion of the Chair if additional meetings are required.

Meetings will be held on the second Thursday of each month and will commence as early as 4:00 p.m., or as approved by the Chair. HCA staff will work with the CAB Chair to determine agendas for the meetings, location of meetings for site visits and will also work collaboratively to determine when scheduled meetings are to be canceled due to lack of agenda items, inclement weather, lack of quorum or other circumstances.

<u>HCA Support & Advisory Staff</u>: As designated by the CAO, appropriate HCA staff shall provide administrative support, including the taking of minutes, the distribution of minutes and agendas and the general administrative coordination of meetings including posting of vacancies for citizen members.

Staff from various HCA divisions shall provide support to the CAB, including background information, briefings, site visits and formal memos and/or reports.

#### 1.0 DEFINITIONS

"Act" means the Conservation Authorities Act, R.S.O. 1990, c. C.27;

"Applicant" means a person who applies for a Permit to engage in an activity prohibited under the Act within the Authority's jurisdiction;

"Application" means a formal request for a Permit to engage in an activity prohibited under the Act within the Authority's jurisdiction;

"Authority" means the Board of Directors of the Hamilton Conservation Authority;

"Executive Committee" means the Executive Committee appointed by the Authority;

"Hearing Board" means the Authority or Executive Committee while it is conducting hearings in accordance with the *Statutory Powers Procedure Act*, R.S.O. 1990, c. S.22. Further to section 28.4 of the *Conservation Authorities Act*, an Authority may also delegate any of its powers relating to the holding of hearings in relation to permits to any other person or body, subject to any limitations or requirements prescribed by regulation;

"Minister" means the Minister of Natural Resources;

"Party" means an Applicant, Permit Holder, or individual subject to a Stop Order;

"Permit" means a permit to engage in otherwise prohibited activities under the Act, issued by the Authority (s. 28.1 and s. 28.1.2 permits) or by the Minister (s. 28.1.1 permits).

"Permit Holder" means a person who holds an active Permit issued by the Authority or a Minister's Permit issued by the Minister;

"Staff" means the employees of the Hamilton Conservation Authority;

"Stop Order" means a stop order issued under section 30.4 of the Act;

"Witness" means a person who is called to speak to evidence presented at a hearing.

#### 2.0 PURPOSE OF HEARING GUIDELINES

The Hearing Guidelines provide a step-by-step process for conducting hearings required under ss. 28.1 (5), ss. 28.1.2 (7), ss. 28.3 (2), (3) and (4), ss. 30.4 (6) of the *Conservation Authorities Act* (CAA) and ss.11(4), (5) and (6) of O. Reg. 41/24. Hearings provide due process and ensure the rights of the Party are upheld.

These guidelines ensure hearings meet the legal requirements of the *Statutory Powers Procedures Act* (SPPA) without being unduly legalistic or intimidating to the participants.

The Hearing Board is empowered by law to make a decision, governed by the SPPA. The Board's decision powers are governed by the CAA and O. Reg. 41/24.

Section 25.1 of the SPPA provides that "a tribunal may make rules governing the practice and procedure before it". The Hearing Rules are adopted under the authority of s. 25.1 of the SPPA. The SPPA applies to the exercise of a statutory power of decision where there is a requirement to hold or to afford the parties to the proceeding an opportunity for a hearing before making a decision. The SPPA sets out minimum procedural requirements governing such hearings and provides rule-making authority for establishing rules to govern such proceedings.

Table 1 below summarizes the legislative and regulatory requirements where a Party is to be provided with an opportunity for a hearing before the Authority, or [where delegated further to s. 28.4 of the CAA] the Executive Committee, or any other person or body [sitting as the Hearing Board].

#### 3.0 ROLE OF THE HEARING BOARD

# 3.1 Apprehension of Bias

In any of the hearing scenarios listed in Table 1 above, the Hearing Board is acting as a decision-making tribunal. The tribunal is to act fairly. Under general principles of administrative law relating to the duty of fairness, the tribunal is obliged not only to avoid any bias but also to avoid the appearance or reasonable apprehension of bias. The following are three examples of steps to be taken to avoid apprehension of bias where it is likely to arise.

- (a) No member of the Authority (or delegate) taking part in the hearing should have prior involvement with the Application or other hearing matter indicated in Table 1 that could lead to a reasonable apprehension of bias on the part of that member. Where a member has a personal interest, the test is whether a reasonably well-informed person would consider that the interest might have an influence on the exercise of the official's public duty. Where a member is a municipal councilor, the *Municipal Conflict of Interest Act* applies. In the case of a previously expressed opinion, the test is that of an open mind, i.e., is the member capable of persuasion in participating in the decision making.
- (b) Any material distributed to the Hearing Board relating to the merits of an Application or other matter indicated in Table 1 that is the subject of a hearing shall also be distributed to the Party at the same time. The Party will be afforded an opportunity to distribute similar pre-hearing material. These materials can be distributed electronically.
- (c) The Party will be given an opportunity to attend the hearing before a decision is made; however, the Party does not have to be present for a decision to be made.

# 3.2 Notice of Hearing

The Party is entitled to reasonable notice of the hearing pursuant to the *SPPA*. The Notice of Hearing shall be sent to the Party within sufficient time to allow the Party to prepare for the hearing. To ensure that reasonable notice is given, the Party will be consulted to determine an agreeable date and time based on the Authority's regular meeting schedule.

In cases where the Authority (or designated Staff) intends to refuse a request for a Permit extension, the Permit Holder must be given at least 5 days' notice of the hearing date, per ss. 11(6) of O. Reg. 41/24. This represents the minimum notice, and other timelines provided in these guidelines may influence the total notice period (e.g., timelines associated with pre-submission of reports).

#### The Notice of Hearing must contain or append the following:

(a) Reference to the applicable legislation under which the hearing is to be held (i.e., the *Conservation Authorities Act*).

- (b) The time, place and the purpose of the hearing (i.e., intent to refuse Application or request for extension, intent to attach conditions, intent to cancel a Permit, and Stop Order).
  - **OR for Electronic / Hybrid Hearings**: The time, purpose of the hearing, and details about the manner in which the hearing will be held. For Electronic or Hybrid Hearings, the Notice must also contain a statement that the Party should notify the Authority if they believe holding the hearing electronically or by hybrid means is likely to cause them significant prejudice. The Authority will assume the Party has no objection to the electronic or hybrid hearing if no such notification is received.
- (c) Particulars to identify the Party, property, and the nature of the matter that forms the subject of the hearing.
- (d) Reasons for the decision / Staff recommendation / action.
  - Reasons shall be specifically stated, and will contain sufficient detail to enable the Party to understand the issues so he or she can be adequately prepared for the hearing. It is sufficient to reference in the Notice of Hearing that the decision / Staff recommendation is based on the reasons outlined in previous correspondence or a hearing report that will follow.
- (e) A statement notifying the Party that the hearing may proceed in the Party's absence and that the Party will not be entitled to any further notice of the proceedings.
  - Except in extreme circumstances, it is recommended that the hearing not proceed in the absence of the Party.
- (f) Reminder that the Party is entitled to be represented at the hearing by a representative such as legal counsel, if desired. The Authority may also be represented at the hearing by counsel or Staff.
- (g) Reminder of protections afforded to the Party under the *Evidence Act*, R.S.O 1990, c. E.23 and the *Canada Evidence Act*, R.S.C., 1985, c. C-5 regarding information provided during hearings (see s. 3.6(a)).
- (h) A copy of the Authority's Hearing Guidelines.

The Notice of Hearing shall be directed to the Party and/or landowner, by registered mail, and other methods as determined advisable (e.g., e-mail). Please refer to Appendices A to E for Notice of Hearing examples.

# 3.3 Meeting Schedule

Hearings will be held on a bi-monthly basis, up to 6 meetings per year, or at the discretion of the Chair if additional meetings are required. Meetings will be held on the second Thursday of each month and will commence at 6:00 p.m., or as approved by the Board of Directors. Meetings will be held on alternate months from the meeting schedule for the Conservation Advisory Board. Therefore, meetings will be held in January, March, May, July, September, and November. Meetings will be cancelled in months when no hearings are requested.

# 3.4 Pre-submission of Reports

Staff may prepare and submit a written report to the Hearing Board in advance of the hearing. A copy of the Staff report will be shared with the Party. The Party shall be provided with the same opportunity to submit a written report to the Hearing Board. The Party shall be given at least two weeks to prepare a report once the reasons for the Staff recommendations have been received. Subsequently, this may affect the timing and scheduling of the Staff hearing reports.

#### 4.0 HEARING

# 4.1 Public Hearing

Pursuant to the SPPA, hearings, including electronic or hybrid hearings, are required to be held in public ("open to the public"). For electronic or hybrid hearings, public attendance should be synchronous with the hearing.

A hearing or part of a hearing may be closed to the public in accordance with the SPPA or the Authority's Administrative By-Laws (e.g., where the Hearing Board is of the opinion that public security matters, intimate financial matters, personal matters, or other matters would be disclosed at the hearing).

# 4.2 Hearing Participants

The Act does not provide for third party status at the hearing. It is only the information presented by the applicant and Authority staff, or their representatives, that will be considered by the hearing-board members. Any information related to the matter that forms the subject of the hearing provided by third parties must be incorporated within the presentation of information by, or on behalf of, the Party or Staff as appropriate.

# 4.3 Attendance of Hearing Board Members

In accordance with case law relating to the conduct of hearings, members of the Hearing Board who will make a Hearing decision must be present during the full course of the hearing. If it is necessary for a member to leave, the remaining members can continue with the hearing and render a decision, provided quorum is maintained.

## 4.4 Adjournments

The Hearing Board may adjourn a hearing on its own motion or that of the Party or Staff where it is satisfied that an adjournment is necessary for an adequate hearing to be held. While adjourned, members of the Hearing Board shall not discuss the matter that is the subject of the hearing.

Any adjournments form part of the hearing record.

#### 4.5 Orders and Directions

In accordance with ss. 9 (2) of the SPPA, a Hearing Board is entitled to make orders or directions to maintain order and prevent the abuse of its hearing processes. A Hearing Procedures example has been included as Appendix F.

# 4.6 Information Presented at Hearings

- (a) The SPPA requires that a Witness be informed of their right to object pursuant to the *Evidence Act*, R.S.O. 1990, c. E.23 ("Evidence Act") and the Canada Evidence Act, R.S.C., 1985, c. C-5 ("CEA"). The Evidence Act and CEA indicate that any answers provided by a Witness during the hearing are not admissible against the Witness in any criminal trial or proceeding.
- (b) It is the decision of the Hearing Board as to whether information is presented under oath or affirmation. It is not a legal requirement. The Party must be informed of the above, prior to or at the start of the hearing.
- (c) The Hearing Board may authorize receiving a copy rather than the original document. However, the Hearing Board can request certified copies of the document if required.
- (d) Privileged information, such as solicitor/client correspondence, cannot be heard.
- (e) Information that is not directly within the knowledge of the speaker (hearsay) can be heard if relevant to the issues of the hearing.
- (f) The Hearing Board may take into account matters of common knowledge (e.g. geographic or historic facts, times, measures, weights, etc.) or generally recognized scientific or technical facts, information or opinions within its specialized knowledge without hearing specific information to inform their decision.
- (g) Staff and the Party shall not present new information at the hearing that has not been submitted to the Hearing Board and the other Party.

# 4.7 Conduct of Hearing

## 4.7.1 Record of Attending Hearing Board Members

Attendance of Hearing Board members shall be recorded at the opening of the hearing.

## 4.7.2 Opening Remarks

The Chairperson shall convene the hearing with opening remarks which generally; identify the Party, the nature of the matter that forms the subject of the hearing (e.g., Application, Permit, Stop Order), and the property location; outline the hearing procedures; and advise on requirements of the *Evidence Act* and the *CEA*. Model Opening Remarks are provided in Appendices G-K.

In an electronic or hybrid hearing, all the parties and the members of the Hearing Board must be able to clearly hear one another and any Witnesses throughout the hearing.

#### 4.7.3 Presentation of Staff Information

Staff present reasons for their recommendations associated with refusal or conditions of approval of the Permit Application, refusal of Permit extensions, cancellations or Stop Orders; in addition to providing legislative/regulatory background and case background. Any reports, documents or plans that form part of the presentation shall be properly indexed and received.

Consideration may be given to the designation of one Staff member or legal counsel who coordinates the presentation of information and asks questions on behalf of all Staff. Additional Staff may participate as required (e.g., technical Staff).

# 4.7.4 Presentation of Party Information

The Party has the opportunity to present information at the conclusion of the Staff presentation. Any reports, documents, or plans which form part of the submission should be properly indexed and received.

The Party shall present information as it applies to the purpose of the hearing (e.g., related to activities covered by the permit application, permit conditions, activities subject to a Stop Order, etc.).

- The Party may be represented by legal counsel or agent, if desired.
- The Party may present information to the Hearing Board and/or have invited advisors to present information to the Board.
- The Party's presentation may include technical Witnesses, such as an engineer, ecologist, hydrogeologist, etc.

#### 4.7.5 Questions

Members of the Hearing Board may direct questions to each speaker as the information is being heard. The Party and/or agent can make any comments or questions on the Staff report.

Pursuant to the SPPA, the Hearing Board can limit questioning where it is satisfied that there has been full and fair disclosure of the facts presented.

#### 4.7.6 Deliberation

After all the information is presented, the Hearing Board may debate and vote in open session or may adjourn the hearing and retire in private to confer. Legal counsel may be secured to advise the Hearing Board when conferring in private. The Board may reconvene on the same date or at some later date to advise of their decision. The Hearing Board members shall not discuss the hearing with others prior to the decision of the Board being finalized.

#### 5.0 DECISION

Hearing participants must receive written notice of the Hearing Board's decision. The Hearing Board shall itemize and record information of particular significance which led to their decision.

It is important that the person who requested the hearing has a clear understanding of the decision, as well as the Party's right to appeal the decision to the Ontario Land Tribunal, the Minister, or other prescribed body (as appropriate and in accordance with the CAA and O. Reg. 41/24). See Appendices L-P for sample Notice of Decision letters.

Table 2 below summarizes the Hearing Board decision powers in accordance with the Act and O. Reg. 41/24, as well as associated appeal rights for the Party.

# 5.1 Notice of Decision

The Notice of Decision should include the following information:

- (a) The identification of the person who requested the hearing, property, and the purpose of the hearing (i.e., Application for a Permit, attaching Permit conditions, request for Permit extension, Stop Order, or cancellation of Permit).
- (b) The decision (as indicated in Table 2 above).

- (c) Written reasons for the decision.
- (d) A copy of the Hearing Board resolution.
- (e) Notice of the Party's right to appeal (as indicated in Table 2 above).

The written Notice of Decision shall be forwarded to the Party by registered mail, and other methods as determined advisable (e.g., e-mail). See Appendices L-P for sample Notice of Decision letters.

# 5.2 Adoption

The Hearing Board shall adopt a resolution containing the decision and any particulars of the decision.

#### 6.0 RECORD

The Authority shall compile a record of the hearing. In the event of an appeal, a copy of the record should be forwarded to the OLT or Minister (as appropriate).

The record must include the following:

- (a) As applicable, copies of the Application for the Permit, the Permit issued, notice of cancellation, or Stop Order that was the subject of the hearing;
- (b) The Notice of Hearing;
- (c) Any orders made by the Hearing Board (e.g., adjournments);
- (d) All information received by the Hearing Board;
- (e) Attendance of Hearing Board members;
- (f) The decision and written reasons for decisions of the Hearing Board; and,
- (g) The Notice of Decision sent to the Party.

**TAKE NOTICE THAT** this hearing is governed by the provisions of the *Statutory Powers Procedure Act*. Under the Act, a witness is automatically afforded a protection that is similar to the protection of the *Ontario Evidence Act*. This means that the evidence that a witness gives may not be used in subsequent civil proceedings or in prosecutions against the witness under a Provincial Statute. It does not relieve the witness of the obligation of this oath since matters of perjury are not affected by the automatic affording of the protection. The significance is that the legislation is Provincial and cannot affect Federal matters. If a witness requires the protection of the *Canada Evidence Act* that protection must be obtained in the usual manner. The Ontario

Statute requires the tribunal to draw this matter to the attention of the witness, as this tribunal has no knowledge of the affect of any evidence that a witness may give.

- 8. The Party and/or their agent may question the Conservation Authority Staff and/or their agent (through the Chair) if reasonably required for full and fair disclosure of matters presented at the Hearing.<sup>14</sup>
- 9. The Hearing Board will question, if necessary, both the Staff and the Party/agent.
- 10. The Hearing Board will move into deliberation. The Hearing Board may also adjourn the hearing and retire in private to confer. For electronic or hybrid meetings, the Hearing Board will deliberate in a manner consistent with practices for in-person hearings (e.g., open vs closed session).

The proceedings will be conducted according to the <u>Statutory Powers Procedure Act</u>. Under section 9 of the <u>Evidence Act</u> and section 5 of the <u>Canada Evidence Act</u>, any witness called may object to answer any question on the ground that the answer may tend to incriminate the person or may tend to establish his/her liability to a civil proceeding at the instance of the Crown or of any person.

Staff have reviewed this proposed work and prepared a staff report, including the proposed conditions of approval for the proposed work, which has been given to the applicant and the Board. The applicant was invited to file material in response to the staff report, a copy of which has also been provided to the Board.

Under section 28.1.2, subsection 7 of the <u>Conservation Authorities Act</u>, the person applying for a permit has the right to a hearing before the Authority [or as delegated to the Authority's Executive Committee or any other person or body, subject to limitations or requirements that may be prescribed by the regulation].

In holding this hearing, the Authority Board/Executive Committee is to determine the prescribed conditions, if any, to be attached to the approved permit. In doing so, we can only consider the application in the form that is before us, the staff report, such evidence as may be given and the submissions to be made on behalf of the applicant. Only information disclosed prior to the hearing is to be presented at the hearing.

The proceedings will be conducted according to the <u>Statutory Powers Procedure Act</u>. Under section 9 of the <u>Evidence Act</u> and section 5 of the <u>Canada Evidence Act</u>, any witness called may object to answer any question on the ground that the answer may tend to incriminate the person or may tend to establish his/her liability to a civil proceeding at the instance of the Crown or of any person.

Subject: Watershed Conditions Report

#### **Executive Summary:**

During the period of February 24<sup>th</sup> to March 24<sup>th</sup> 2025, there were no significant watercourse flooding events nor Lake Ontario shoreline flooding events. However, three rain and snowmelt events warranted issuing messages and additional monitoring of watercourse conditions. The most recent event resulted in significant water safety concerns and localized watercourse flooding of low-lying areas that typically flood during higher water levels.

There are no observations, reports, or expectations that significant watercourse flooding is occurring at this time. However, water levels and flows in Lower Spencer Creek continue to be elevated and pose significant water safety concerns. Localized watercourse flooding of low-lying areas that typically flood during higher water levels may also be occurring at this time within Lower Spencer Creek.

The average monthly flows for March so far have ranged between slightly below long-term averages to significantly above long-term averages

Currently, there are no observations, reports, or expectations that significant Lake Ontario shoreline flooding is occurring. The Lake Ontario mean daily water level averaged across the entire lake was 7 cm below average for this time of year, as of yesterday.

Current Christie Lake and Valens Lake levels are above preferred winter operating levels, but well below preferred summer operating levels.

There are currently two potential rain events forecasted for the watershed over the next 2 weeks, on April 3<sup>rd</sup> and 6<sup>th</sup>. One these two days, there is also currently forecasted

potential for high wave events. HCA staff will continue to monitor forecasts closely, as well as reassess the potential for flooding. Flood messaging will be issued as warranted.

HCA staff will continue to undertake monthly drought assessments, and coordinate with the Hamilton Low Water Response Team as required if drought conditions are identified.

#### Staff Comment / Discussion:

#### CURRENT WATERSHED CONDITIONS - March 24th, 2025

#### <u>Current Flows in Major Area Watercourses</u>

There are no observations, reports, or expectations that significant watercourse flooding is occurring at this time. However, water levels and flows in Lower Spencer Creek continue to be elevated and pose significant water safety concerns. Localized watercourse flooding of low-lying areas that typically flood during higher water levels may also be occurring at this time within Lower Spencer Creek. Lower Spencer Creek water levels are expected to continue decreasing generally, but are expected to continue to pose significant water safety concerns this week. There are currently no known significant water safety concerns for other watercourses within the HCA watershed, with water levels and flows being slightly elevated above baseflows.

The average monthly flows for March so far have ranged between slightly below long-term averages to significantly above long-term averages. Monthly flow in Upper Spencer Creek at Safari Road has been 95% of long-term averages (considered near average). Monthly flow in Middle Spencer Creek at Highway 5 has been 85% (considered slightly below average). Monthly flow in Lower Spencer Creek at Market Street has been 223% (considered significantly above average). Monthly flow in Ancaster Creek at Wilson Street has been 106% (considered near average). Monthly flow in Red Hill Creek at Barton Street has been 120% (considered slightly above average).

In January and February, ice conditions artificially affected readings at the streamflow gauges, thus flow measurements were not considered accurate. Also, Lower Spencer Creek at Market Street water levels were artificially elevated at times over this period due to planned in-water work related to the Creighton Road bridge work immediately downstream of the gauge

December 2024 average recorded flows ranged between significantly below long-term averages to near long-term averages. Monthly flow in Upper Spencer Creek at Safari Road was 51% of long-term averages (considered well below average). Monthly flow in Middle Spencer Creek at Highway 5 was 39% (considered significantly below average). Monthly flow in Lower Spencer Creek at Market Street was 64% (considered below average). Monthly flow in Ancaster Creek at Wilson Street was 96% (considered near average). Monthly flow in Red Hill Creek at Barton Street was 83% (considered slightly below average). The precipitation amounts recorded at the streamflow gauges do not explain the variations in average monthly recorded flows. There was also no significant thunderstorm activity during the month. It is therefore expected that the variations in average monthly recorded flows are likely due to temporary storages of runoff in the

Valens and Christie Lake reservoirs during rainfall events, as well as differences in local rainfall received in the ungauged areas upstream of each streamflow gauge.

#### **Current Lake Ontario Water Levels**

At this time, there are no observations, reports, or expectations of significant Lake Ontario shoreline flooding. The Lake Ontario mean daily water level in the Hamilton area was 74.67 m IGLD85 as of yesterday. The Lake Ontario mean daily water level averaged across the entire lake (74.62 m IGLD85 as of yesterday) is 7 cm below average for this time of year.

#### Current Storages in HCA Reservoirs

Current Christie Lake levels (766.13 ft) are above preferred winter operating levels (765.30 to 765.80 ft), but well below preferred summer operating levels (771.00 to 771.50 ft).

Current Valens Lake levels (274.78 m) are above preferred winter operating levels (274.15 to 274.40m), but well below preferred summer operating levels (275.25 to 275.45 m).

#### **Current Soil Conditions**

Surface and root-zone soils are considered wet to saturated across the watershed, and are expected to be fully thawed to partially frozen.

#### **RECENT STORM EVENTS**

During the period of February 24<sup>th</sup> to March 24<sup>th</sup> 2025, there were no significant watercourse flooding events nor Lake Ontario shoreline flooding events.

However, three rain and snowmelt events warranted issuing messages and additional monitoring of watercourse conditions. The most recent event resulted in significant water safety concerns and localized watercourse flooding of low-lying areas that typically flood during higher water levels.

#### Potential for Watercourse Flooding During Rain and Snowmelt Event

February 26th to February 28th

Prior to this event, 10 mm of snowmelt was forecasted for the Hamilton area on February 25<sup>th</sup>, with an additional up to 28 mm of combined rain and snowmelt expected on February 26<sup>th</sup>. There was considerable uncertainty as to the amount of runoff that would occur. HCA staff continued to monitor watercourse and weather conditions closely, and reassessed the potential for flooding.

There were no received observations, reports, or expectations of significant watercourse flooding or significant water safety concerns.

HCA engineering staff issued the following messages related to this event, to communicate the potential watercourse flooding and water safety concerns to the City and public:

- February 24<sup>th</sup>: Flood Watch Inland Lake and River Flooding
- February 28th: Cancellation Flood Watch Inland Lake and River Flooding

### Potential for Watercourse Flooding During Rain and Snowmelt Event March 4<sup>th</sup> to March 7<sup>th</sup>

Prior to this event, up to 17 mm of combined rain and snowmelt was forecasted for the Hamilton area on March 4<sup>th</sup>, with an additional up to 35 mm of combined rain and snowmelt expected on March 5<sup>th</sup>. There was considerable uncertainty as to the amount of runoff that would occur. HCA staff continued to monitor watercourse and weather conditions closely, and reassessed the potential for flooding.

There were no received observations, reports, or expectations of significant watercourse flooding or significant water safety concerns.

HCA engineering staff issued the following messages related to this event, to communicate the potential watercourse flooding and water safety concerns to the City and public:

- March 3<sup>rd</sup>: Flood Watch Inland Lake and River Flooding
- March 7<sup>th</sup>: Cancellation Flood Watch Inland Lake and River Flooding

## Potential for Watercourse Flooding During Rain and Snowmelt Event March 15<sup>th</sup> to ongoing

Prior to this event, the remaining area snowpack was expected to melt, followed by up to 15 mm of rain forecasted for the Hamilton area on March 15<sup>th</sup>, with an additional up to 10 mm of rain expected on March 16<sup>th</sup>. Preceding water levels and flows in Lower Spencer Creek were already elevated and posed significant water safety concerns, while preceding water levels and flows in other area watercourses were elevated but did not pose significant water safety concerns at that time. There was considerable uncertainty as to the amount of runoff that would occur. HCA staff continued to monitor watercourse and weather conditions closely, and reassessed the potential for flooding.

There were no received observations, reports, or expectations of significant watercourse flooding, however there were significant water safety concerns in Upper, Middle and Lower Spencer Creek, as well as Ancaster Creek, based on peak water levels and flows. Also,

localized watercourse flooding of low-lying areas that typically flood during higher water levels was expected to have occurred in these areas.

HCA engineering staff issued the following messages related to this event, to communicate the potential watercourse flooding and water safety concerns to the City and public:

- March 11<sup>th</sup>: Flood Watch Inland Lake and River Flooding
- March 17<sup>th</sup>: Watershed Conditions Statement (Water Safety) Inland Lake and River Flooding
- March 21<sup>st</sup>: Watershed Conditions Statement (Water Safety) Inland Lake and River Flooding

#### RECENT WATERSHED LOW WATER CONDITIONS

For the most recent drought assessment (including data up to February 28), the 3-month precipitation totals indicated normal / Level 1 Low Water conditions within the watershed, based on data at the 8 available stations. However, the 18-month precipitation totals indicated normal conditions within the watershed, as did the average flows over the month at 4 of the 5 available streamflow gauges.

Given this and the reduced irrigation demands at this time of year, a decision on declaring a Level 1 Low Water condition was deferred until the next scheduled assessment at the beginning of April.

#### FORECASTED WATERSHED CONDITIONS

#### Watercourse Flooding

There are currently two potential rain events (+20 mm in a day) forecasted for the watershed over the next 2 weeks, on April 3<sup>rd</sup> and 6<sup>th</sup>.

HCA staff will continue to monitor weather forecasts closely, as well as reassess the potential for flooding. Flood messaging will be issued as warranted.

#### Lake Ontario Shoreline Flooding

There are currently two potential high wave events forecasted for the shoreline over the next 2 weeks, on April 3<sup>rd</sup> and 6<sup>th</sup>.

HCA staff will continue to monitor Lake Ontario levels, wind and wave forecasts closely, as well as reassess the potential for flooding. Flood messaging will be issued as warranted.

#### Watershed Low Water Conditions

HCA staff will continue to undertake monthly drought assessments, and coordinate with the Hamilton Low Water Response Team as required if drought conditions are identified.

Subject: Conservation Area Services Update

#### **Executive Summary:**

HCA provides high quality, diverse conservation areas that promote outdoor recreation, health and well being and strengthen public awareness of the importance of being in or near our conservation areas.

#### **Staff Comment / Discussion:**

#### Conservation Areas Operations

After a long, cold and snowy winter, all of our areas will be preparing for the upcoming season. Reopening our areas is a collective effort across all of our departments. Fleet Services division is busy transitioning away from snow removal equipment and preparing our turf equipment. The Capital and Strategic Serviced division will be busy making repairs and turning on seasonal utilities to our washrooms, campgrounds and pavilions. Boat lift in will begin at Fifty Point Conservation Area with all slips booked for the season.

#### Easter Weekend

All of our major conservation areas will be open and welcoming visitors over the long weekend. With warmer temperatures on the way, we are anticipating an increase to visitation during the holiday weekend. Staff will continue work closely with Municipal Parking Enforcement to monitor and report on visitation. The Special Enforcement Areas in effect from March 15 until November 15.

#### Dundas Valley

Specific sections within the Dundas Valley Conservation area will be temporarily closed for Jefferson Salamander migration. This seasonal closure is in collaboration with Watershed Management Services to promote healthy habitats and support species at risk.

#### Watershed Tree Planting Initiatives

HCA is committed to enhancing biodiversity across the watershed through multiple tree planting initiatives. In partnership with Trees for Hamilton, volunteers and staff will plant approximately 600 trees this spring and fall at various Conservation Areas and Confederation Beach Park. Additionally, through the 50 Million Tree Program, HCA has partnered with Conservation Halton to plant 3,210 trees at Eramosa Karst Conservation Area, reforesting 4.5 acres of open field. Planting will begin in spring 2025, with HCA staff responsible for monitoring and maintaining the trees. These efforts strengthen our natural spaces and build valuable partnerships for future conservation projects.
