Recommendation:

THAT the Hamilton Region Source Protection Authority endorses the proposed amendments to the Halton-Hamilton Source Protection Region Agreement for drinking water source protection in the Halton-Hamilton Source Protection Region; and

THAT the Hamilton Region Source Protection Authority approves the renewal of the Halton-Hamilton Source Protection Region Agreement for a five (5)-year term expiring October 2030

Executive Summary:

The current Halton-Hamilton Source Protection Region agreement expired on September 30, 2025.

Staff has reviewed the agreement and recommend revisions to the membership of the Halton-Hamilton Source Protection Region Management Committee, specifically removing the Chair and Vice-Chair of each source protection authority from the membership of the management committee. This reflects that the source protection program is an established and mature program and that oversight and coordination of the program can be delegated to staff. Staff also recommends revisions to the responsibilities of the Halton-Hamilton Source Protection Management Committee for

tasks that have been taken on by the program manager and no longer need to be listed as responsibilities of the management committee.

The Halton-Hamilton Source Protection Management Committee reviewed the proposed revisions on October 3, 2025, and recommended endorsing the revisions and approving the renewal of the partnership agreement for a five (5) year term expiring in October 2030.

Staff Comment / Discussion:

Staff has reviewed the current agreement and is proposing the following changes.

Revisions to Halton-Hamilton Source Protection Management Committee Membership

The current membership of the Halton-Hamilton Source Protection Management Committee is comprised of the Chair and Vice-Chair, Chief Administrative Officer/President & CEO and Senior Staff Liaison of each source protection authority in the region. The Chair of the Halton-Hamilton Source Protection Committee is an ex officio member of the management committee.

Staff recommends removing the Chair and Vice-Chair of each source protection authority from the membership of the management committee. The Chief Administrative Officer/President & CEO, and Senior Staff Liaison of each source protection authority, together with the Source Protection Committee (SPC) Chair as an ex officio member, would comprise the new management committee.

The source protection program is an established and mature program. Oversight and coordination of the program between the two (2) source protection authorities through the management committee can be delegated to staff. The Halton Region and Hamilton Region Source Protection Authorities are regularly updated at source protection authority meetings through annual progress reporting and program updates.

Revisions to Responsibilities of Halton-Hamilton Source Protection Management Committee

Current responsibilities of the management committee are outlined in Section 5.3 of the partnership agreement (Attachment 1) and include developing annual work plans and budgets, establishing reporting procedures for the program manager and technical team, and coordinating reports to the SPC. For several years, these responsibilities have been taken on by the program manager and no longer need to be listed as responsibilities of the management committee. Responsibilities such as hiring the source protection program manager, setting program priorities in accordance with direction and funding from the Ministry of the Environment, Conservation and Parks, and liaising with municipalities in the region are important management committee responsibilities that should remain.

Staff also recommends additions and updates to the definitions (e.g., Ex officio Member, Senior Staff Liaison), and clarifications and editorial revisions for clarity and readability. The revised partnership agreement highlighting the updates in track changes is attached as Attachment 1.

Submission

Staff recommends endorsing the proposed amendments to the Halton-Hamilton Source Protection Region Agreement for drinking water source protection in the Halton-Hamilton Source Protection Region and approving the renewal of the Halton-Hamilton Source Protection Region Agreement for a five (5)-year term expiring October 2030.

The Halton-Hamilton Source Protection Management Committee reviewed the proposed revisions on October 3, 2025, and recommended endorsing the revisions and approving the renewal of the partnership agreement for a five (5) year term expiring in October 2030.
